Introduction

Postwick with Witton is preparing a neighbourhood plan which will include a policy designating areas of Local Green Space which are particularly valued by the community. A robust process has been followed to determine which green spaces within Postwick with Witton should be designated.

Initial ideas were suggested by residents and the steering group as part of consultation activities in 2024. In Q15 of the initial community survey, residents were asked about green spaces in the parish that they would like to see protected. This was a free text question that 38 people chose to answer and **everyone who answered supported the idea of protecting green space**. Some respondents gave specific suggestions for spaces to protect which are listed below. **The spaces that were mentioned multiple times were: areas around the river, village hall playing fields, Postwick Grove, and the park and ride extension site.** Suggestions included:

These spaces were reviewed to consider whether they would meet the national criteria for designation with regard to the National Planning Policy Framework and Planning Practice Guidance.

A site visit was undertaken by the working group for the sites wishing to be taken forward and further evidence gathered including:

- Reviewing any historic evidence related to the green spaces on the Historic England website and via Heritage Gateway;
- Reviewing Statutory or Local Designations within mapped data sources available in the public domain via Natural England, Historic England, Norfolk County Council, Broadland District Council and Broads Authority;
- An assessment against the national criteria for Local Green Space was made for each of the potential areas;
- Landowners were contacted to make them aware that their land was being considered for local green space designation and to invite them to make representations;
- A final decision was recommended by the Steering Group, and confirmed by the parish council, as to which green spaces to designate.

This document provides the assessment and reasoning of all six areas of green space visited or suggested for us to investigate to include in the neighbourhood development plan. Chapter 3 provides the assessment and explanation of the green spaces we feel are justified and supported to be a LGS in the Postwick with Witton Neighbourhood Plan.

Policy Context

Local Green Space designation is a way to provide special protection for green areas of particular importance to local communities. The National Planning Policy Framework (NPPF) published in 2012 (revised December 2023) introduced the concept of Local Green Space designation.

Paragraph 105 of the NPPF sets out that communities should be able to identify green spaces of particular importance through neighbourhood plans, with para 106 Determining:

The Local Green Space designation should only be used where the green space is:

- a) *In reasonably close proximity to the community, it serves;*
- b) *Demonstrably special to a local community and holds a particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and*
- c) *Local in character and not an extensive tract of land¹.*

In addition, the National Planning Practice Guidance states:

Local Green Space designation will rarely be appropriate where the land has planning permission for development. Exceptions could be where the development would be

compatible with the reasons for designation or where planning permission is no longer capable of being implemented.

Other designations, such as Special Areas of Conservation, do not necessarily preclude or support designation as a Local Green Space. However, it is necessary to consider whether the additional designation is necessary and would serve a useful purpose.

In applying the NPPF criteria, close proximity would normally mean easy walking distance, which based on Natural England standards would mean 1.25 miles or less.

Consideration of whether the green space is local in character, and not an extensive tract of land, suggests spaces within a locality, rather than for example, extensive green areas in the countryside.

The Broadland District Local Plan and Broads Authority Local Plan includes strategic policies for the neighbourhood area. Planning Practice Guidance on Neighbourhood Planning sets out that plans must be in general conformity with the strategic policies of the development plan if it is to meet the basic conditions. Green spaces are mentioned a few times in the relevant Local Plan Policies which are relevant for the designated area, and this includes:

- Policy EN2 of the Broadland Development Management DPD (2015) sets out that development proposals should consider any impact upon as well as seek to protect and enhance where appropriate green spaces including natural and semi-natural features as well as geological/geomorphological features which make a significant contribution towards defining the character of an area.
- Policy 3 of the Greater Norwich Local Plan (2024) states that development proposals should enhance the natural environment through respecting landscape character and retaining important views and features... and sensitive areas such as green spaces identified in Local or Neighbourhood Plans.
- In Policy SSLGS of the Broads Local Plan (2019) development proposals that protect or enhance local green spaces and that comply with other relevant policies will be permitted. Development proposals that would have unacceptable adverse impact on the use, function and appearance of these local green spaces or would result in their loss will not be permitted other than in very special circumstances.

Assessment of the green spaces being designated

The Local Green Space Assessment Tool from My Community: Neighbourhood Planning Local Green Spaces² has been used as the basis to assess each site identified by the community. This includes:

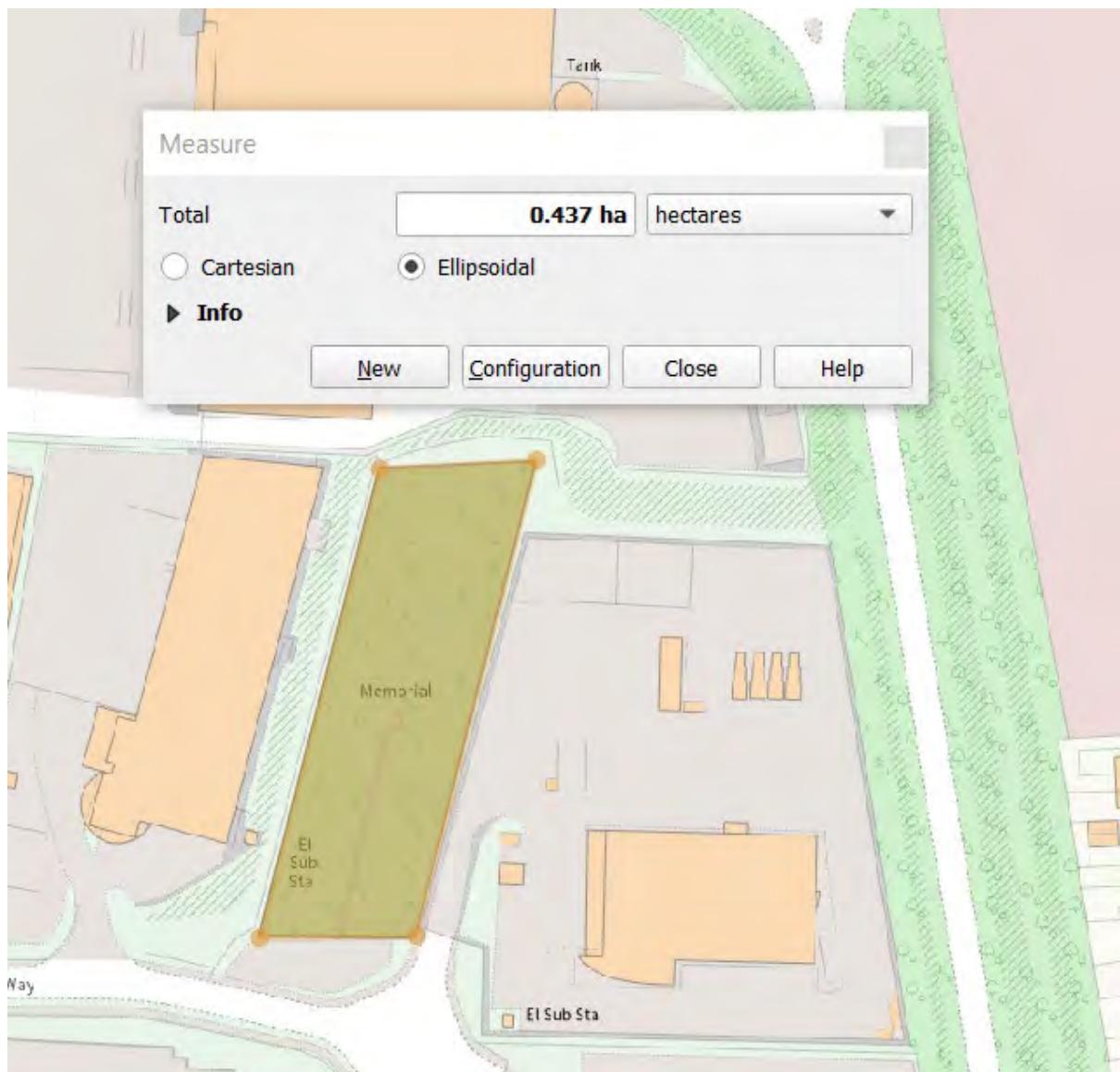

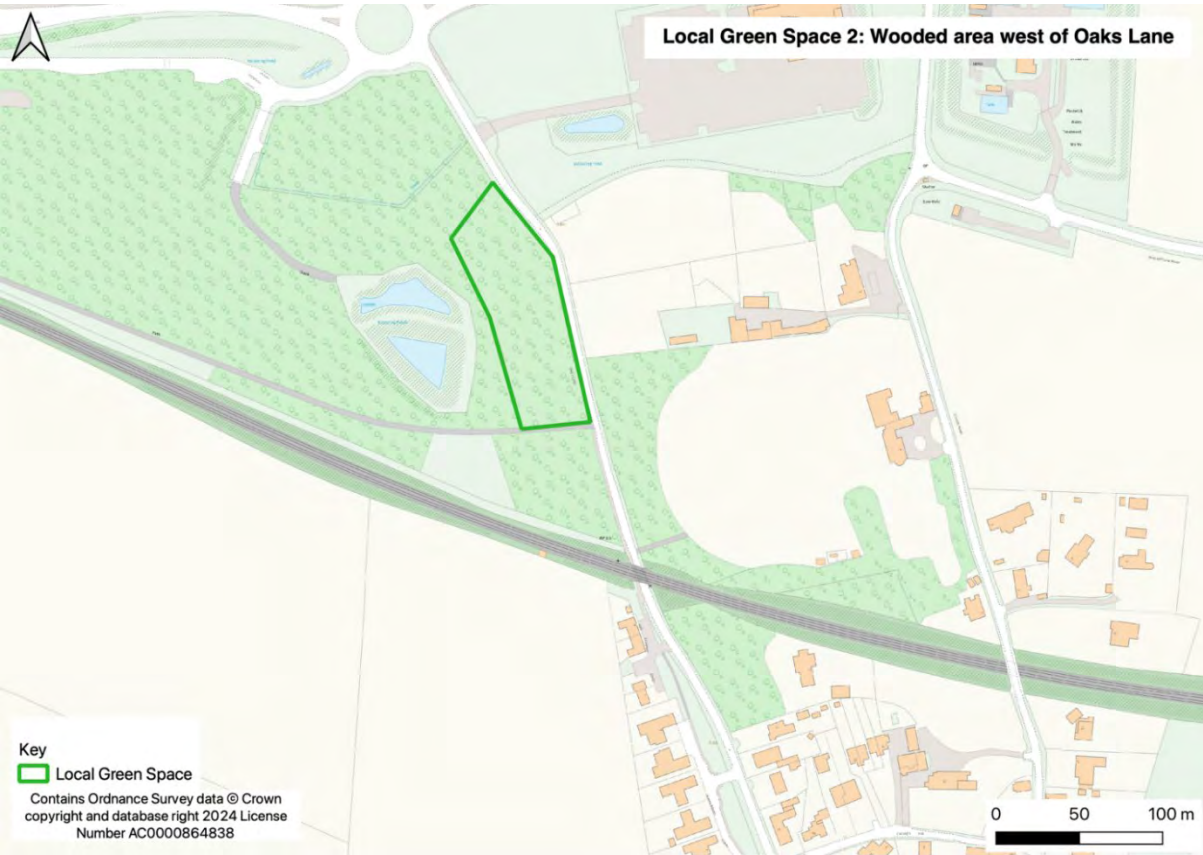

LGS2- Wooded Area, West of Oaks Lane

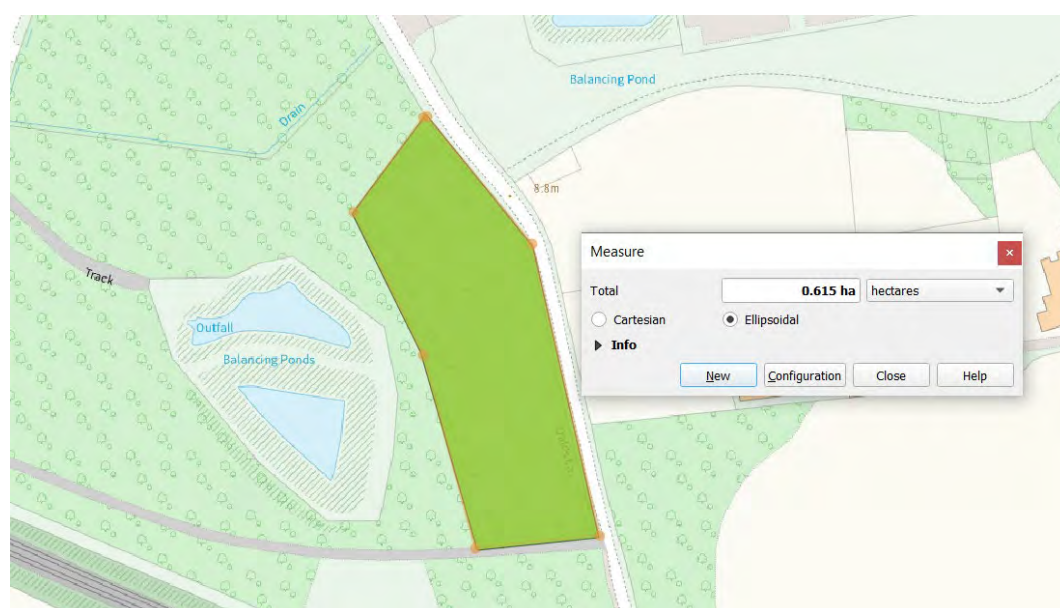
Description and purposes	<p>The wooded area just off Oaks Lane, between the roundabout at the top of Oaks lane and the park and ride footpath.</p> <p>This is a relatively new green space created when the drainage works were made for the Postwick junction on the land leased by Norfolk CC for a planned but now defunct extension to the park and ride. Small trees were planted along a small edge of the land bordering Oaks Lane which now has a path that meanders through it enabling walkers to join a permissive path up to Brundall Low Road past the Plymouth Brethern meeting room. This means pedestrians do not have to walk along the single lane road which has no footpath, high banks and a sharp bend.</p> <p>This path goes off the tarmac path to the Park and ride off Oaks Lane (what3words explored.gourmet.excavate) and meanders through trees to return to oaks lane nearer the roundabout.</p> <p>(sheepish.snooping.joystick). It is approximately 80m in length (parallel with Oaks Lane by 30m width).</p>

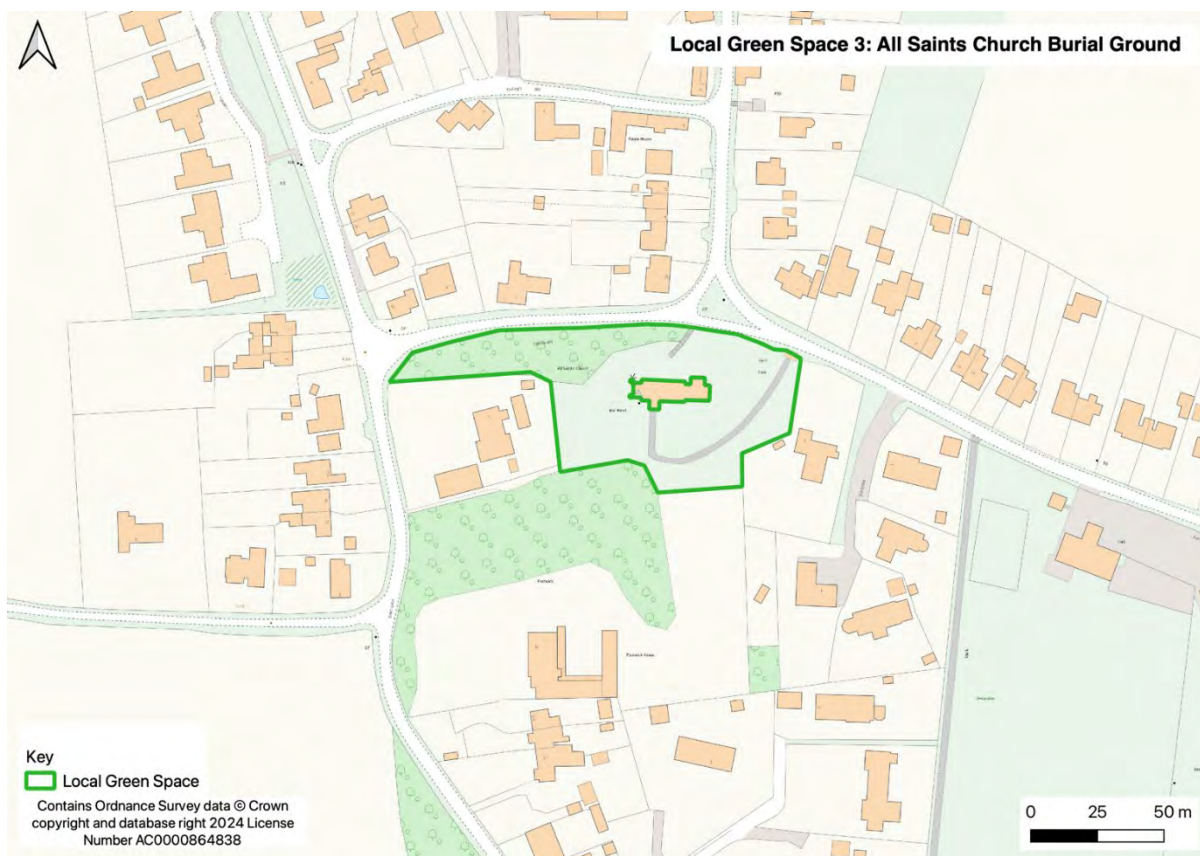

It has a high recreational value which also attracts wildlife, and the landowner keeps bees on the site. One of the villagers carries out moth and butterfly surveys here. 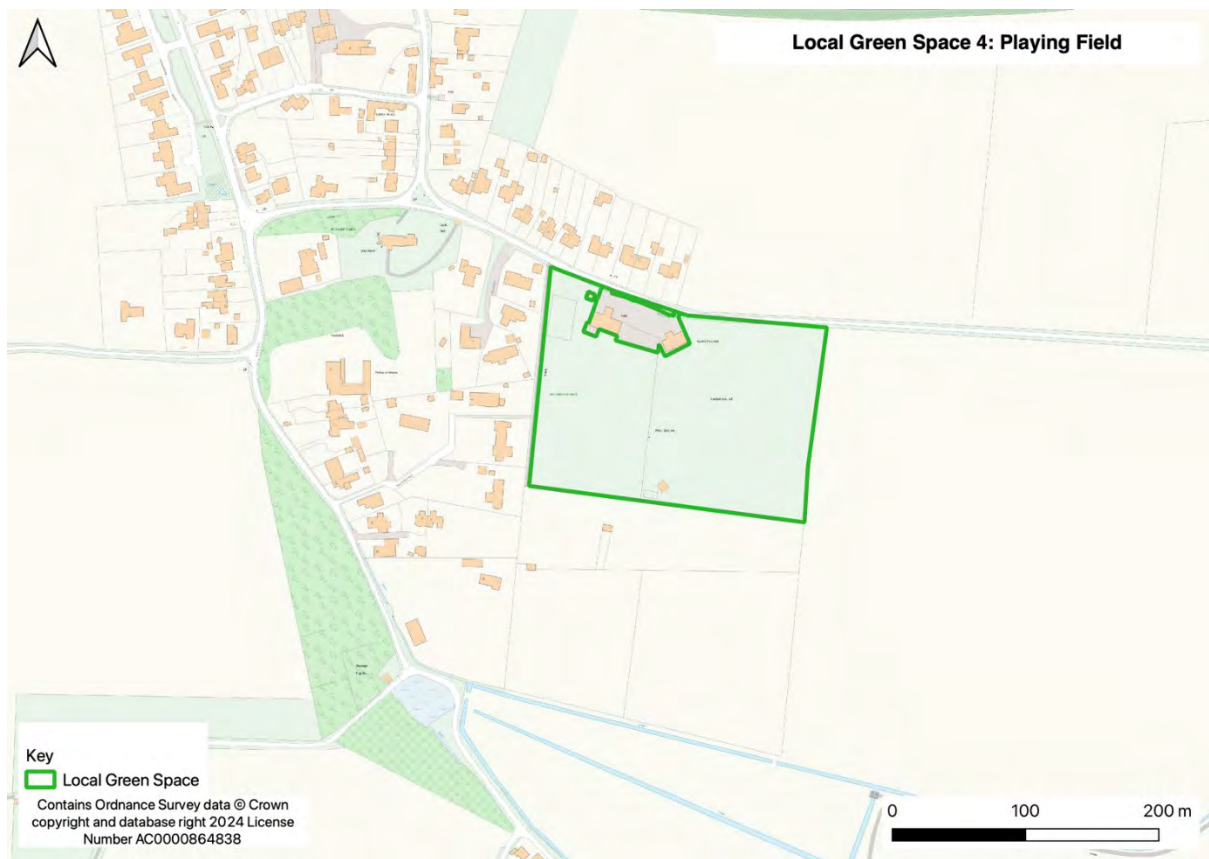

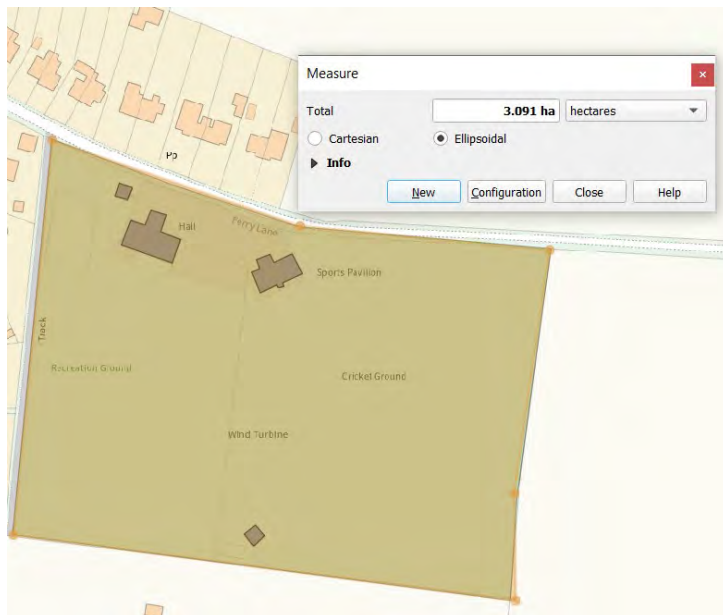

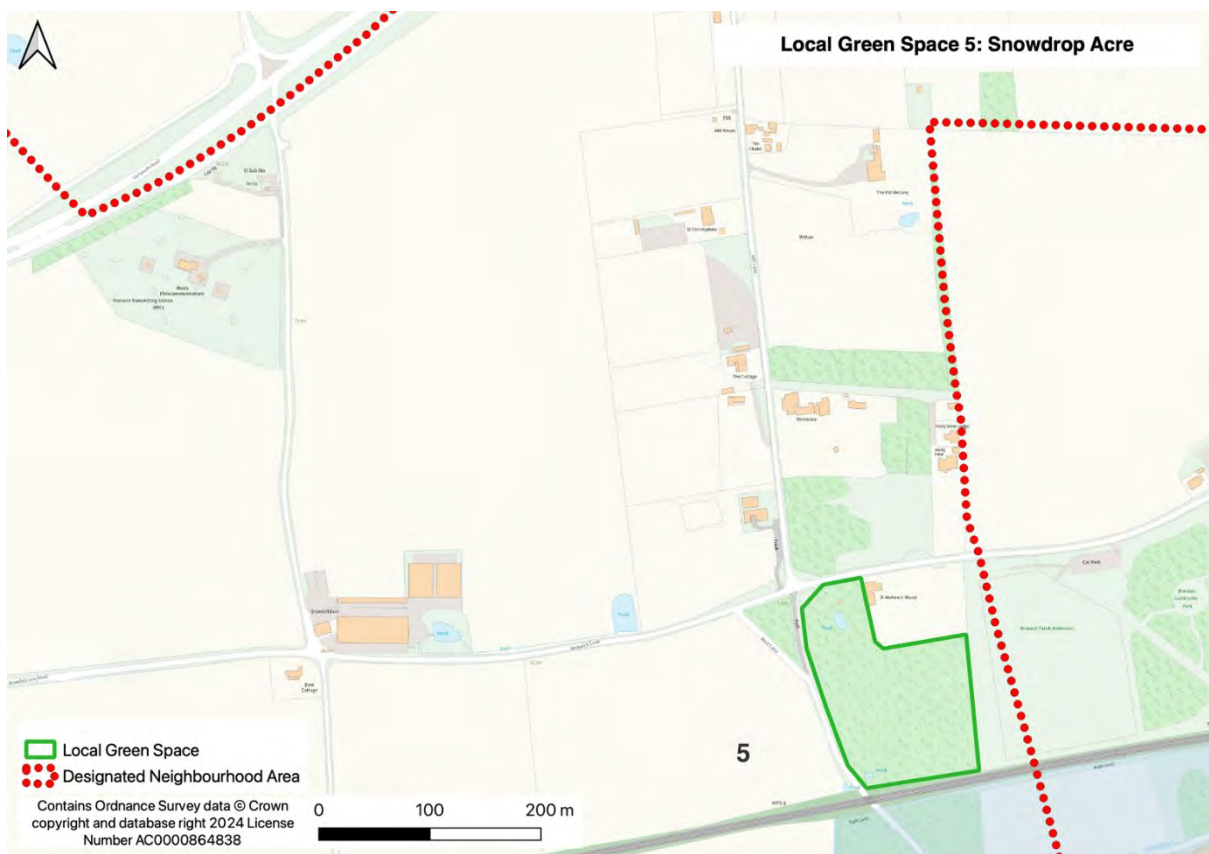

This would not be considered appropriate.</p> <p>The recreation ground is not an extensive tract of land and serves as a green space for the local community and is considered an appropriate size in proportion to the village itself.</p>



LGS5- Snowdrop Acre, Witton

Site	Snowdrop Acre, Witton West off West Lane what3words: hang.nylon.buck
Description and purposes	This greenspace is off West Lane (leading to the Marina) and within short walking distance from properties in Witton (South). The area is in the back of a garden where there is a large snow drop field ⁵ . The District Council owns this land, and the greenspace is managed by Blofield and District Conservation Group (BADCOG). Recently been in the news because of its historical and botanical importance to the community ⁶ . It is considered one of the fifteen important conservation and wildlife sites in the area the BADCOG look after. Managed by BADCOG since 1985 in collaboration with BDC.

Close to the community it serves. Add distance to centre of village	The greenspace is in reasonable distance to the core of the village and within 200m walking distance to other residential dwellings.
	<p>This greenspace is considered to have historic benefit and wildlife benefit to the local area. The site was once the garden of decorated WWI hero Hayrick Antony Greatorex. He moved to Norfolk with his family in 1915, and after the war he pioneered the breeding of snowdrops. More varieties of named snowdrops are derived from his garden than any other in Britain⁷.</p> <p>Habitats: Woodland garden, pond, hedgerow. Despite the site's small size several interesting bird species have been recorded, including tawny owl, goldcrest, marsh tit, and siskin.</p> <p>Main Conservation Interest: Winter/early spring ground flora, woodland pond, wych elms.</p> <p>Description on the BADCOG website:</p> <p>In 1985 BADCOG began managing this site by removing encroaching scrub and tall vigorous herbaceous vegetation. A large debris pile, made up from the cleared material, now provides a habitat for invertebrates and small mammals, perhaps including the bank voles which have been seen on the site. The garden still contains a range of interesting</p>

	<p>ornamental trees, shrubs and flowering plants, including oso berry <i>Osmaronia cerasiformis</i> from western North America, the climber <i>Akebia quinata</i> from China and Japan, and <i>Hydrangea aspera</i> from the Himalay and southeast Asia. A mature Indian horse chestnut <i>Aesculus indica</i> grows in the hedgerow next to the gate.</p> <p>The garden's exotic trees and shrubs are interspersed among native species which have been augmented by recent plantings. A wide range has been used, with hazel, holly, and oak predominant. Selective felling of sycamore, grey poplar and Douglas fir has been undertaken to prevent excessive shading of the winter/early spring ground flora, and to allow space for the growth and development of preferred tree species. Two mature wych elms are a notable feature of the garden. Further interest is added by a shaded, semi-permanent woodland pond which dries out periodically. Whether or not it is man-made and how long it has existed is not known, but it forms a distinctive and valued feature of the old garden.</p> <p>Rather than attempt to revert the site back to semi-natural woodland, the management aim is to retain the garden's ornamental character, in keeping with its recent history. The garden will be restored and enhanced, maintaining its woodland framework interspersed with exotic plants. 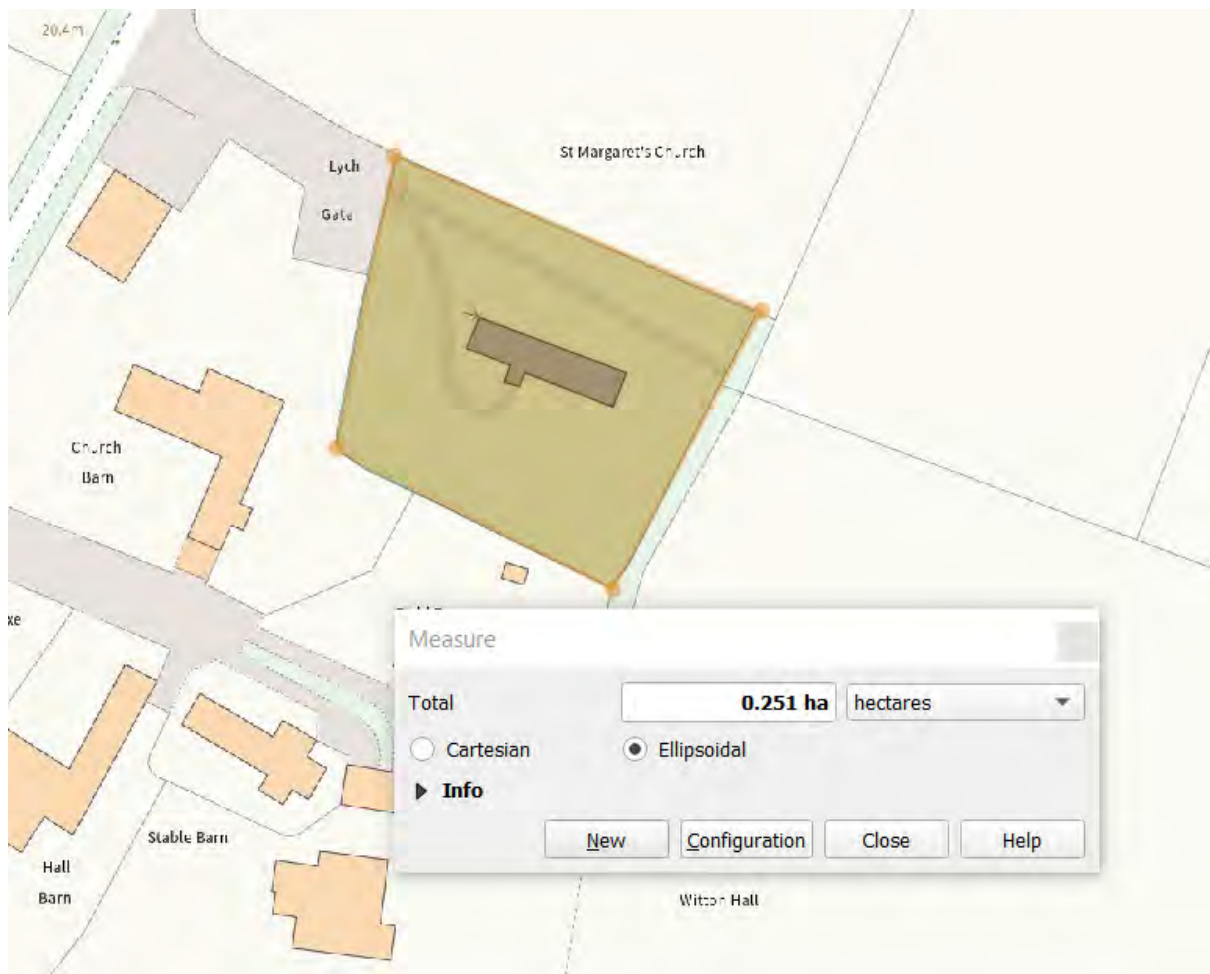

Recommended Designations

From the assessment work, 6 Local Green Spaces have been determined to meet the national criteria for designation. These are highlighted below.
