

THIS AGREEMENT is made the 28th day of August one thousand nine-hundred and ninety BETWEEN BROADLAND DISTRICT COUNCIL of Thorpe Lodge Yarmouth Road Norwich in the County of Norfolk (hereinafter called "the Council") of the one part and VALERIE LANKESTER KNIGHTS of The White House North Burlingham in the said County (hereinafter called "the Owner") of the other part

WHEREAS

1. The Council is the Local Planning Authority for the purposes of this Agreement

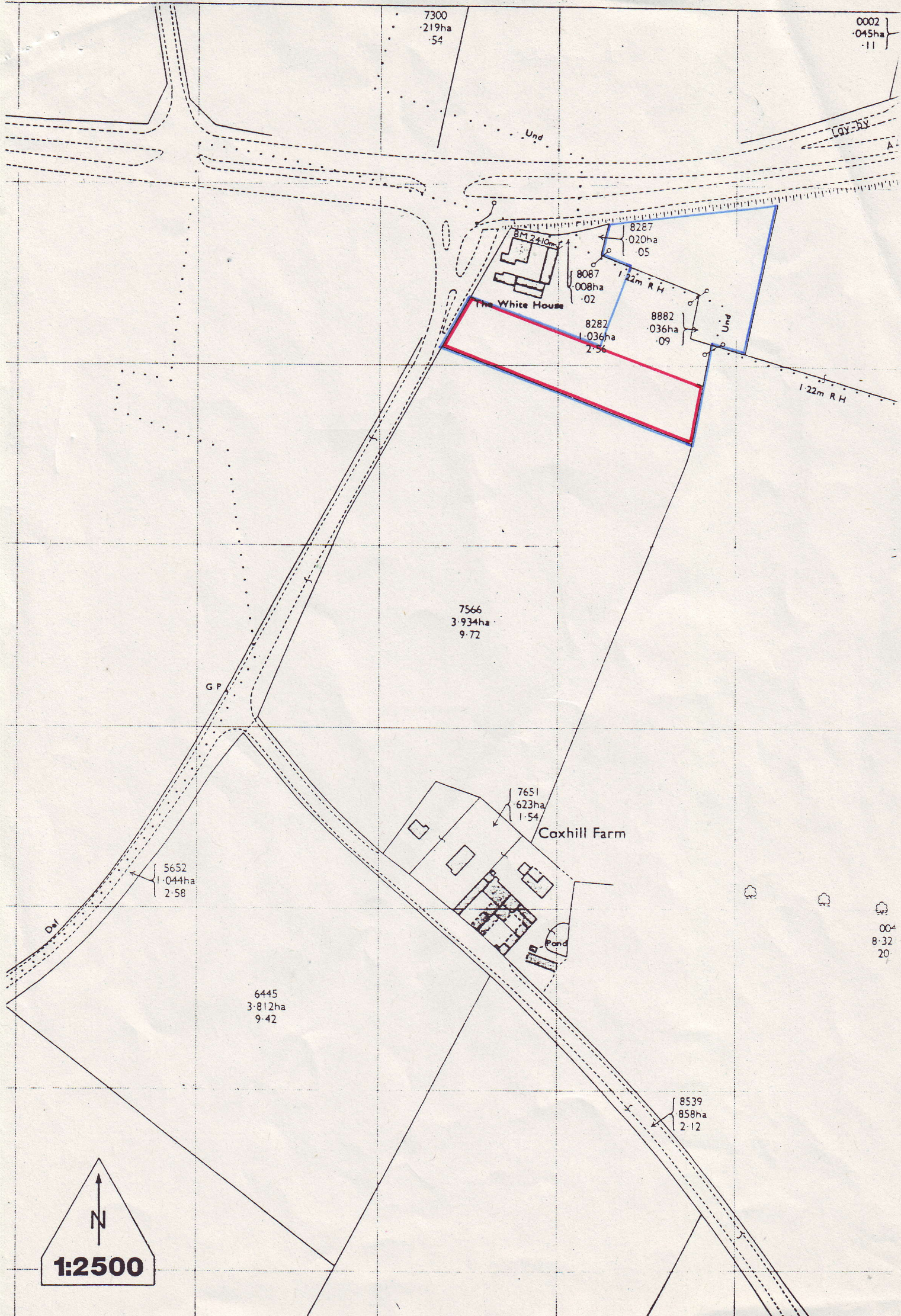
 2. The Owner is seized in fee simple absolute in possession of the land situate in the parish of ^{BEIGHTON V.L.K.} ~~Burlingham~~ and abutting the A.47 trunk road there and as lineated on the plan annexed hereto and thereon shown edged red (hereinafter called "the Red Land") free from incumbrances

3. The Owner has applied to the Council under reference number 90.0911 for planning permission for development to be carried out on the land delineated on the plan annexed hereto and shown thereon edged blue (hereinafter called "the Blue Land") which Blue Land includes the Red Land

4. The Council and the Owner have agreed subject to planning permission being granted in consequence of that application to enter into this Agreement pursuant to Section 106 of the Town and Country Planning Act 1990

NOW THIS DEED WITNESSETH as follows:

(1) Subject to planning permission being granted in consequence of application number 90.0911 and pursuant to the said Section 106 the Owner hereby agrees declares and covenants with the Council that from the date on which that planning permission shall be granted the Red Land shall be permanently subject to the conditions restricting or regulating development or use of the Red Land specified in the Schedule hereto



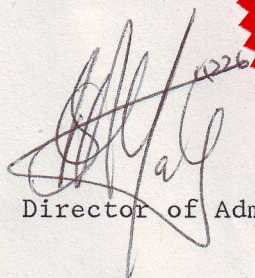
(2) The expressions "the Council" and "the Owner" shall where the context so admits include their respective successors in title and assigns

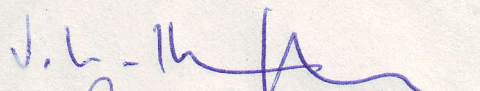

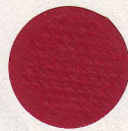
