

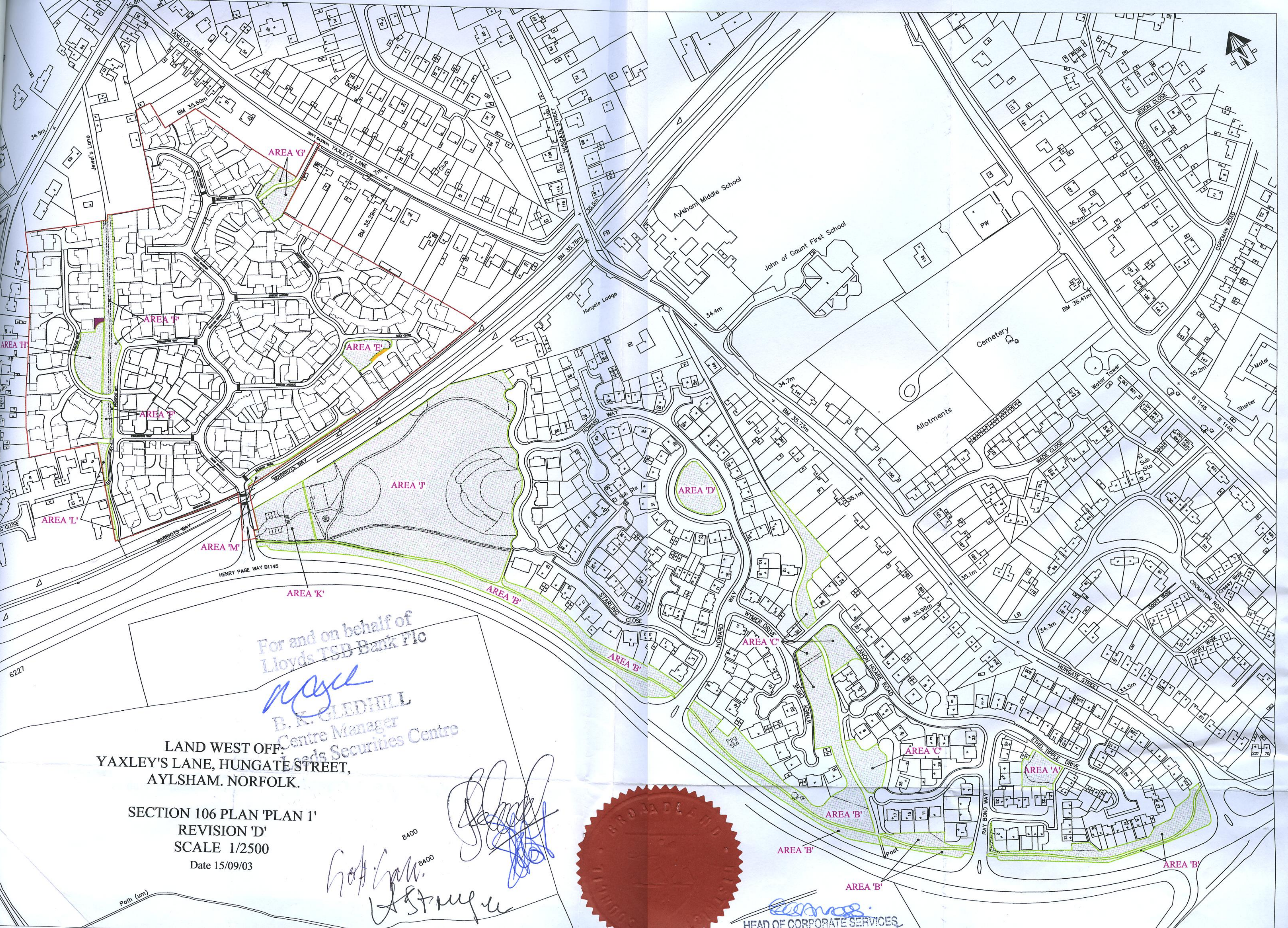

WHEREAS:-

- (1) The obligations imposed by this Agreement are planning obligations for the purpose of section 106 of the Town & Country Planning Act 1990 (hereinafter called "The 1990 Act") as amended by Section 12 of the Planning and Compensation Act 1991.
- (2) The Council is the Local Planning Authority by whom these obligations are enforceable.
- (3) The Council the Owner the Mortgagee and the Town have previously entered into an Agreement dated 6th December 2002 (hereinafter referred to as "the Main Agreement") but now wish to amend the terms of the Main Agreement

NOW THIS DEED WITNESSES as follows:-

1. SUBJECT to the terms of this Agreement and pursuant to the said Section 106 of the 1990 Act as amended the Council the Owners the Mortgagee and the Town hereby AGREE DECLARE AND COVENANT for themselves and their successors in title that the Main Agreement shall be further varied with effect

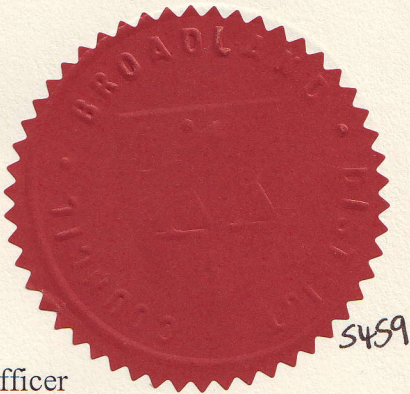

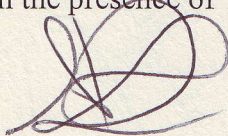
