WHEREAS

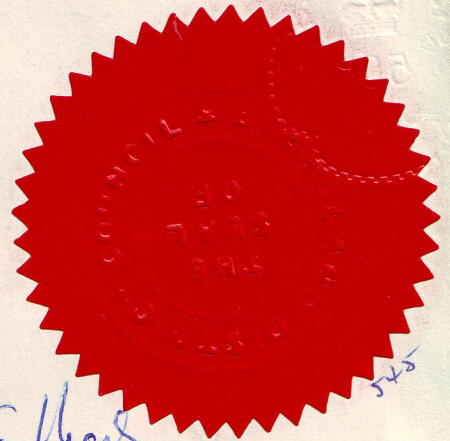
- (1) The Council is the Local Planning Authority for the purposes of this agreement

NOW THIS DEED WITNESSETH as follows:-

1. Pursuant to Section 52 of the said Act the Owner hereby agrees declares and covenants with the Council that the Property shall permanently be subject to the conditions (restricting or regulating the development or use of the Property) specified in the Second Schedule hereto.
2. The expressions "the Council" and "the Owner" shall where the context admits include their respective successors in title and assigns
