

THIS DEED OF VARIATION is made the *Fourteenth* day of *July*
One thousand nine hundred and ninety five BETWEEN **BROADLAND**
DISTRICT COUNCIL of Thorpe Lodge Yarmouth Road Norwich in the
County of Norfolk (hereinafter called "the Council") of the one
part and **HONOR ANN SERRUYS** of Tawny Lodge Pound Lane Thorpe St
Andrew in the County of Norfolk (hereinafter called "the Owner")
of the other part and is supplemental to an Agreement (hereinafter
called "the Agreement") dated the 5th day of November 1985 made
between the Council of the one part and John James Miller of the
other part relating to premises at Pound Lane Thorpe St Andrew as
defined in the Agreement (hereinafter called "the Premises")

WHEREAS

(1) **THE** fee simple absolute in possession of the Premises is now
vested in the Owner

(2) **THE** Planning Permission 85.0340 referred to in the Agreement
has been superceded by the Permissions and events set out in the
Schedule hereto (hereinafter together called "the Development
Plans")

(3) **THE** Council has agreed to enter into this Deed in manner
hereinafter appearing

NOW THIS DEED WITNESSETH:-

1. **IN** pursuance of the said agreement and in consideration of
the Premises and the Development Plans the Council **HEREBY AGREES**
that the implementation of all the works and provisions authorised
by the Development Plans shall not be deemed to be in breach of
the Agreement and in particular the provisions of the Third
Schedule thereof to the intent that the implementation of the
Development Plans shall not give rise to any claims or proceedings

by the Council against the Owner arising under the Agreement or otherwise

IN WITNESS whereof the Council has hereunto caused their common seal to be affixed and the Owner has set her hand the day and year first before written


