

THIS AGREEMENT is made the 19th day of June One thousand nine hundred and ninety BETWEEN BROADLAND DISTRICT COUNCIL of Thorpe Lodge Yarmouth Road Norwich in the County of Norfolk (hereinafter called "the Council") of the first part DEREK GORDON HICKMAN and HAZEL HICKMAN both of Amberley Lodge Great Witchingham in the said County (hereinafter together called "the Owners") of the second part and LLOYDS BANK PLC of 16 Gentlemans Walk Norwich in the said County (hereinafter called "the Bank") of the third part

WHEREAS

(1) This Agreement is supplemental to an Agreement (hereinafter called "the Agreement") made between the parties hereto on the tenth day of August One thousand nine hundred and eighty nine

(2) The Owners have applied to the Council under reference number 89.2563 for planning permission for the construction of a building on the property which is intended to be constructed by them in substitution for that authorised by the Council under planning permission reference number 89.0347 referred to in the Agreement

(3) The Council the Owners and the Bank have agreed subject to planning permission being granted in consequence of application reference number 89.2563 to enter into this Agreement pursuant to Section 52 of the Town and Country Planning Act 1971

NOW THIS DEED WITNESSETH as follows:

(1) Subject to planning permission being granted in consequence of application number 89.2563 and pursuant to the said Section 52 the parties hereto hereby agree and declare that at all times after the grant of planning permission reference number 89.2563 the Agreement shall be read construed and take effect as though the word "said" was omitted from the first line of the Schedule to the Agreement and the words and numbers "all reference number 89.2563" were inserted in the second line of that Schedule immediately after the number "89.0347"

(2) The parties hereto hereby confirm in all other respects the Agreement.
