W H E R E A S :-

(1) The Authority is the District Planning Authority for the purposes
of the Town and Country Planning Act 1990 ("the Act") for the area
within which the land shown edged red on the annexed plan ("the Land")
is situated

(2) The Owners are the owners in fee simple in possession of the Land

(3) The Owners have made application (reference 90/0887) in accordance
with the Act and the orders and regulations for the time being in
force thereunder for planning permission to develop the Land by the
replacement of an existing chalet ("the Chalet")

N O W T H I S D E E D W I T N E S S E T H as follows:-

1. This Agreement is made in pursuance of Section 106 of the Act
Section 33 of the Local Government (Miscellaneous Provisions) Act 1982
and all other enabling powers

2. The Owners hereby covenant jointly and severally with the Authority
that in the event of planning permission being granted for the
Chalet:-

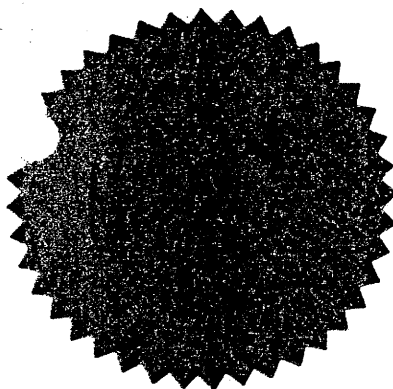
(i) they will make and keep up to date a register of bookings

(ii) they will not cause or permit the Chalet to be occupied
between 5th January and 17th March and 1st November and 20th
December inclusive in any year

3. The expressions "the Authority" and "the Owners" shall include their respective successors and assigns as appropriate within the terms of Section 106 of the Act

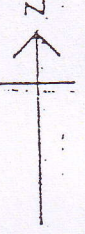
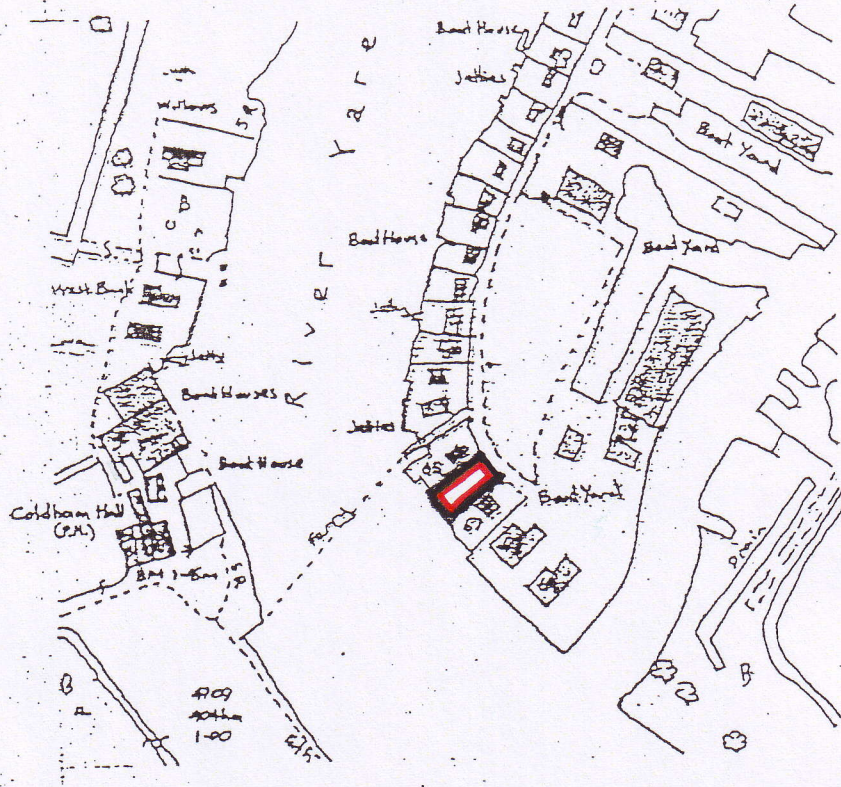

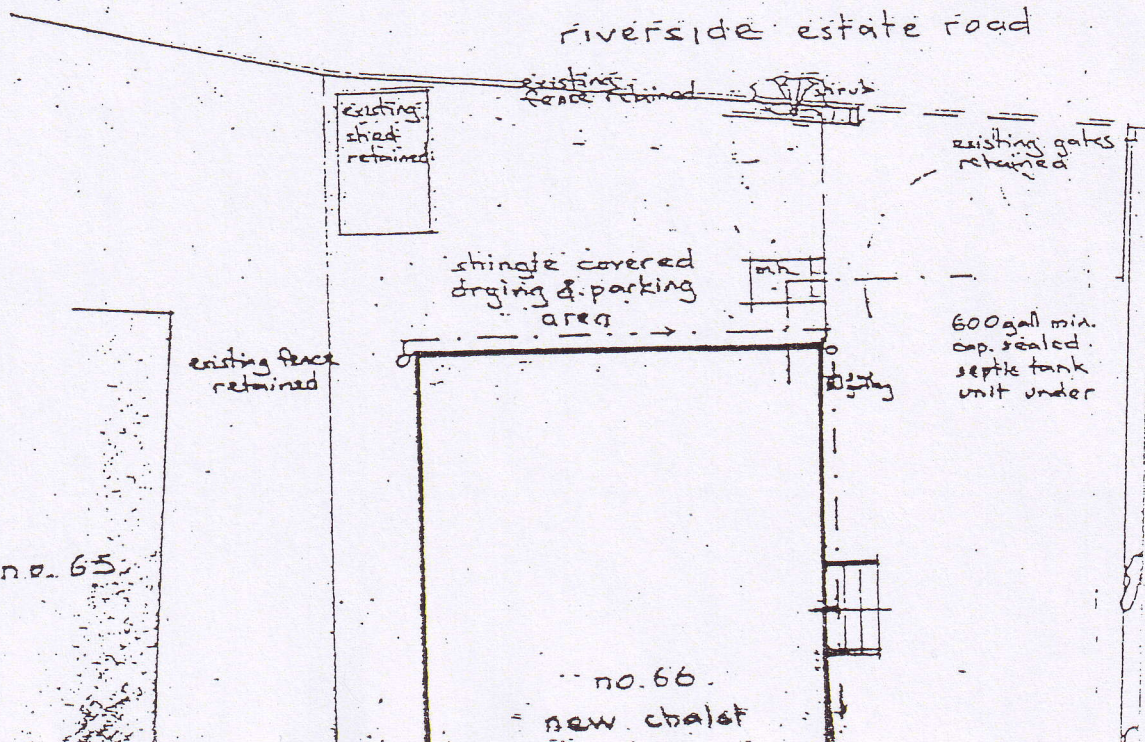
