DECLARATIONS OF INTEREST AT MEETINGS

When declaring an interest at a meeting Members are asked to indicate whether their interest in the matter is pecuniary, or if the matter relates to, or affects a pecuniary interest they have, or if it is another type of interest. Members are required to identify the nature of the interest and the agenda item to which it relates. In the case of other interests, the member may speak and vote. If it is a pecuniary interest, the member must withdraw from the meeting when it is discussed. If it affects or relates to a pecuniary interest the member has, they have the right to make representations to the meeting as a member of the public but must then withdraw from the meeting. Members are also requested when appropriate to make any declarations under the Code of Practice on Planning and Judicial matters.

Have you declared the interest in the register of interests as a pecuniary interest? If Yes, you will need to withdraw from the room when it is discussed.

Does the interest directly:

1. Affect yours, or your spouse / partner's financial position?
2. Relate to the determining of any approval, consent, licence, permission or registration in relation to you or your spouse / partner?
3. Relate to a contract you, or your spouse / partner have with the Council
4. Affect land you or your spouse / partner own
5. Affect a company that you or your partner own, or have a shareholding in

If the answer is "yes" to any of the above, it is likely to be pecuniary.

Please refer to the guidance given on declaring pecuniary interests in the register of interest forms. If you have a pecuniary interest, you will need to inform the meeting and then withdraw from the room when it is discussed. If it has not been previously declared, you will also need to notify the Monitoring Officer within 28 days.

Does the interest indirectly affect or relate any pecuniary interest you have already declared, or an interest you have identified at 1-5 above?

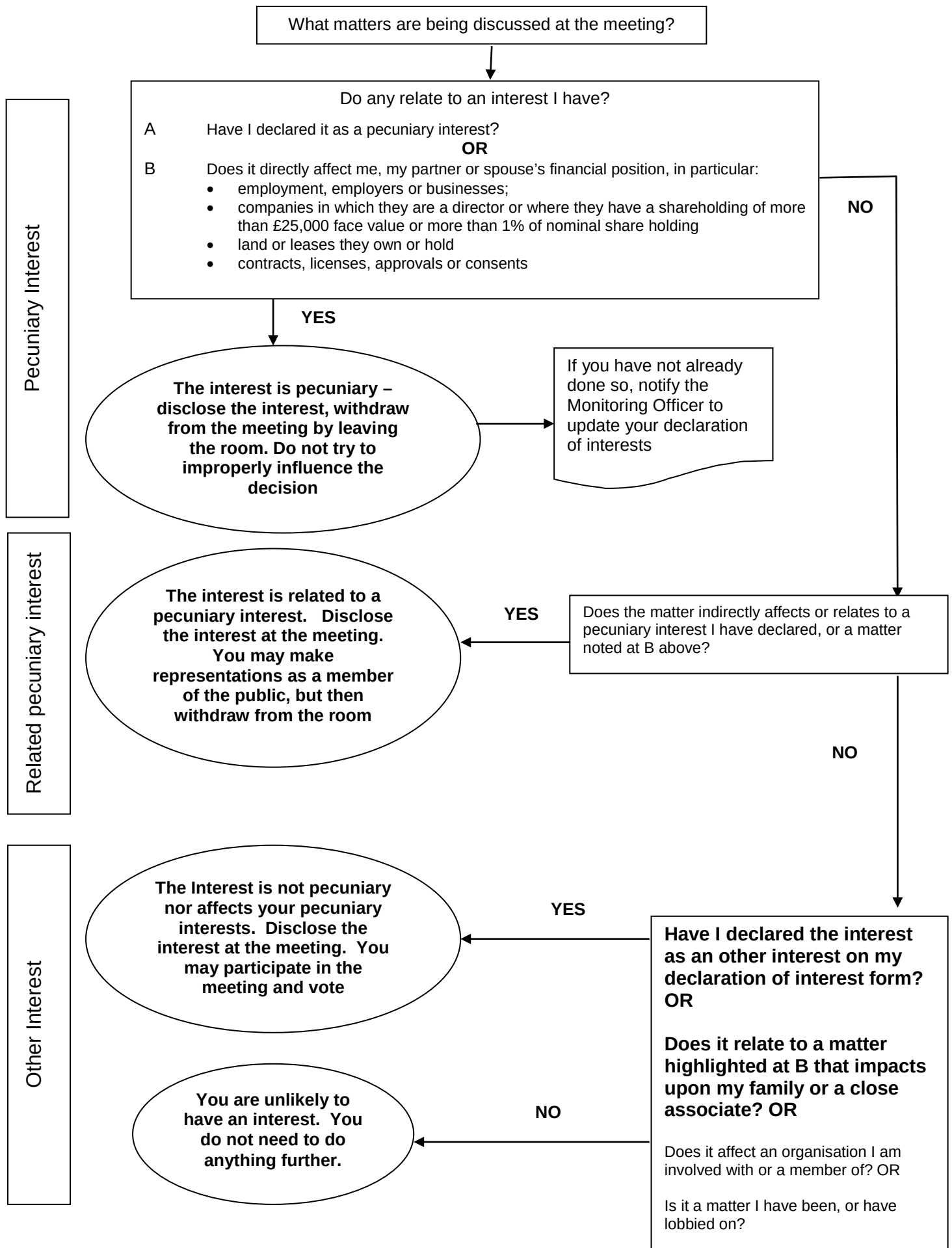
If yes, you need to inform the meeting. When it is discussed, you will have the right to make representations to the meeting as a member of the public, but must then withdraw from the meeting.

Is the interest not related to any of the above? If so, it is likely to be another interest. You will need to declare the interest, but may participate in discussion and voting on the item.

Have you made any statements or undertaken any actions that would indicate that you have a closed mind on a matter under discussion? If so, you may be predetermined on the issue; you will need to inform the meeting, and when it is discussed, you will have the right to make representations to the meeting as a member of the public, but must then withdraw from the meeting.

30 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr Cook and Cllr Walker.

31 MINUTES

The Minutes of the meeting held on 5 March 2020 were confirmed as a correct record.

32 ENVIRONMENTAL STRATEGY

The report presented the Environment Strategy, which was based on key themes to improve the local environment, as well as helping to address the wider environmental challenges of the global community.

The Panel had considered and commented on the draft Strategy at its meeting on 5 March 2020 and their suggestions had been incorporated in the final draft along with those of South Norfolk's Growth Infrastructure and Environment Policy Committee.

The report requested that the Panel consider and recommend that Cabinet approved the Environmental Strategy and the Work so far document.

The Chairman read to the Panel her Foreword for the Strategy:

The challenge we all face with regard to climate change is recognised across the globe. It is not a problem Broadland District Council can solve on its own. It means taking a lead with new initiatives, ensuring planning applications comply to all environmental regulations, partnership working with others, signposting communities, businesses and individual residents to ways in which we can improve our environment for future generations. Our plan is a living document and encompasses work which we started some time ago. It builds on our successes. As a council Broadland has the highest recycling rate in Norfolk and leads on largest tonnage of green waste. But we must all do better recycling more and generating less residual waste. We will be putting our own house in order using greener vehicles, exploiting technology to reduce business travel and eradicating single use plastics. I invite you all to work with us, on this journey, to protect and enhance our environment.

In response to the suggestion that the Council should aim to be carbon neutral by 2030, the Director of Place advised the meeting that this would require a fundamental change of mind-set in respect of Broadland's delivery of services and would have massive financial implications for the Council. For example the huge costs of a carbon neutral waste collection fleet or turning Thorpe Lodge into a carbon neutral office.

He estimated that even to do a feasibility study for such a project would take at least a year before it could be brought back Panel, as the resources for this were not currently available.

Members confirmed that they would like to see the additional resource put in place to carry out this work.

The Leader advised the Panel that this was an issue that would be considered when the Strategy was brought to Cabinet. He added that Members would need to have a clear understanding of where the funding would be found to meet such a target.

The Panel then went through the Environmental Strategy and made the following comments and amendments:

- Page 3
 - The Government's aim to be carbon neutral by 2050 should be noted, but the Strategy should set a more ambitious timescale and direct a dedicated resource to achieve it.
- Page 4
 - Insert a paragraph to explain that Broadland and South Norfolk were rural areas, with limited public transport and were, therefore, more reliant on cars which increased their emissions of CO₂.
- Page 5
 - It would preferable to compare both Districts with Norfolk as a whole, rather than Norwich.

- Page 7
- Baseline fly tipping data should be reported consistently in the Strategy. It was noted that page 7, referred to 2016/17, whilst page 28 referred to 2018/19 data.
 - It was questioned whether the cost of enforcement action against fly tippers represented value for money.
- Page 8
- Clarify that the spring clean of the Districts was carried out annually, as part of a national campaign.
 - Make clear that the work being carried out with town and parish councils was in relation to street scene services.
- Page 9
- It was noted that the Annual Air Quality report showed that although Broadland and South Norfolk did not have any areas where air quality management was a notifiable problem, there were areas where air quality was poorer than desirable. Monitoring in these areas would continue to be undertaken.
 - Comparisons with national air quality figures should also be included.
- Page 10
- Under '*how can you help us?*' refer to reducing use of fossil fuels.
- Page 11
- Explain that pre-planning application support would include advice on the tax benefits of land remediation expenditure.
 - Abridge the section on domestic heating oil spills.
 - Under '*what we are going to do?*' include: Encourage residents to move to a cheaper low carbon fuel or technology.
- Page 12
- Amend the following paragraph:

Developments in flood risk areas ~~can only be considered~~ is generally resisted in flood risk areas and would only be considered when informed by a site-specific Flood Risk Assessment that identifies all sources of flooding and robustly demonstrates how these will be managed.
 - Under '*how you can help us?*' add the following bullet points
 - Install permeable driveways.
 - Fit soakaways and green barriers.
 - Garden with plants that require less water.

- Page 13
- The Strategic Approach for Sustainable Communities in respect of resilience should refer to 'communities', rather than 'residents'.
 - Sustainable Communities should be moved closer to the beginning of the Strategy. This was especially important in the light of the Covid-19 pandemic.
- Page 14
- The sign up for flood warnings web address should be turned into a shorter hyperlink.
 - A typographical error was identified.
- Page 15
- Make efficient use of land with densities dependent on-site characteristics, with higher densities and car free housing in the most sustainably accessible locations. ~~in Norwich. Indicative minimum densities are 25 dwellings per hectare across the plan area and 40 in Norwich.~~
- Page 17
- Use the best environmental management practices for land use to protect and enhance biodiversity. *Such as creating wildlife corridors between green infrastructure.*
- Page 21
- Combine the following bullet points:
 - Recycle more, recycle right – you can find out what goes in which bin.
 - Don't contaminate your bin.
 - Create a hyperlink for this web address on this page
 - Under '*how can you help us?*' include: home composting
 - Encourage ~~Breadland~~ residents to engage with food waste collections, where available.
 - Under Strategic approach add: Investigate opportunities to expand food waste service if possible.
- Page 23
- Review our own ~~fleet of vehicles~~ *policy*
 - ~~Investigate all options for new refuse depot with the potential to develop infrastructure to help us move to a greener fleet of vehicles.~~
- Page 24
- Include totals in the staff/member mileage and emissions table.
 - Under staff travel emphasise that home working would

continue to be encouraged.

- Investigate the infrastructure and installation required for the delivery of electric vehicle charging points. ~~at all council owned buildings.~~

Page 28 • Add the figures for 2018/19 litter picks and clean up initiatives supported.

Page 31 • Any initiatives to recycle and reduce contamination being promoted by the Council should be included in the delivery column.

- Broadland to be inserted in front of gross tonnage increase – food waste.

- Add a recycling target of 60% over the five years of the plan.

Page 32 • Staff/Members mileage figures to be added.

Work so far

- Page 50 • Add Harrisons Wood to the list of projects under the tree planting strategy.
- Reference funding secured by Broadland and Norfolk County Council from the Bure Valley Railway Path, and include quantitative information on footpaths, where possible.

Page 53 • Refer to *Broadland Thorpe* Lodge.

Page 54 • Delete reference to Zero Taxis, as they were no longer operating.
