Wymondham Area Action Plan, Policies Map



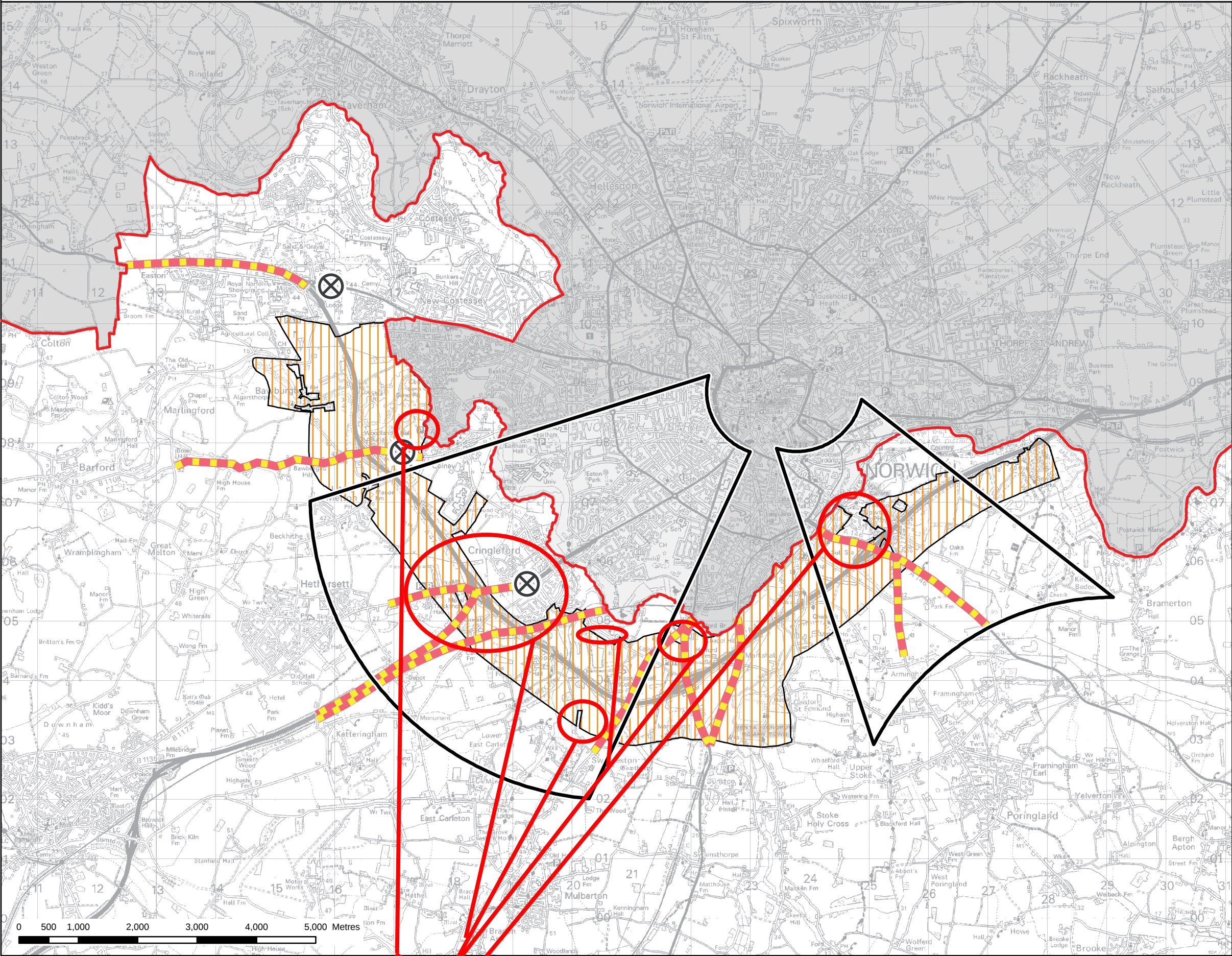

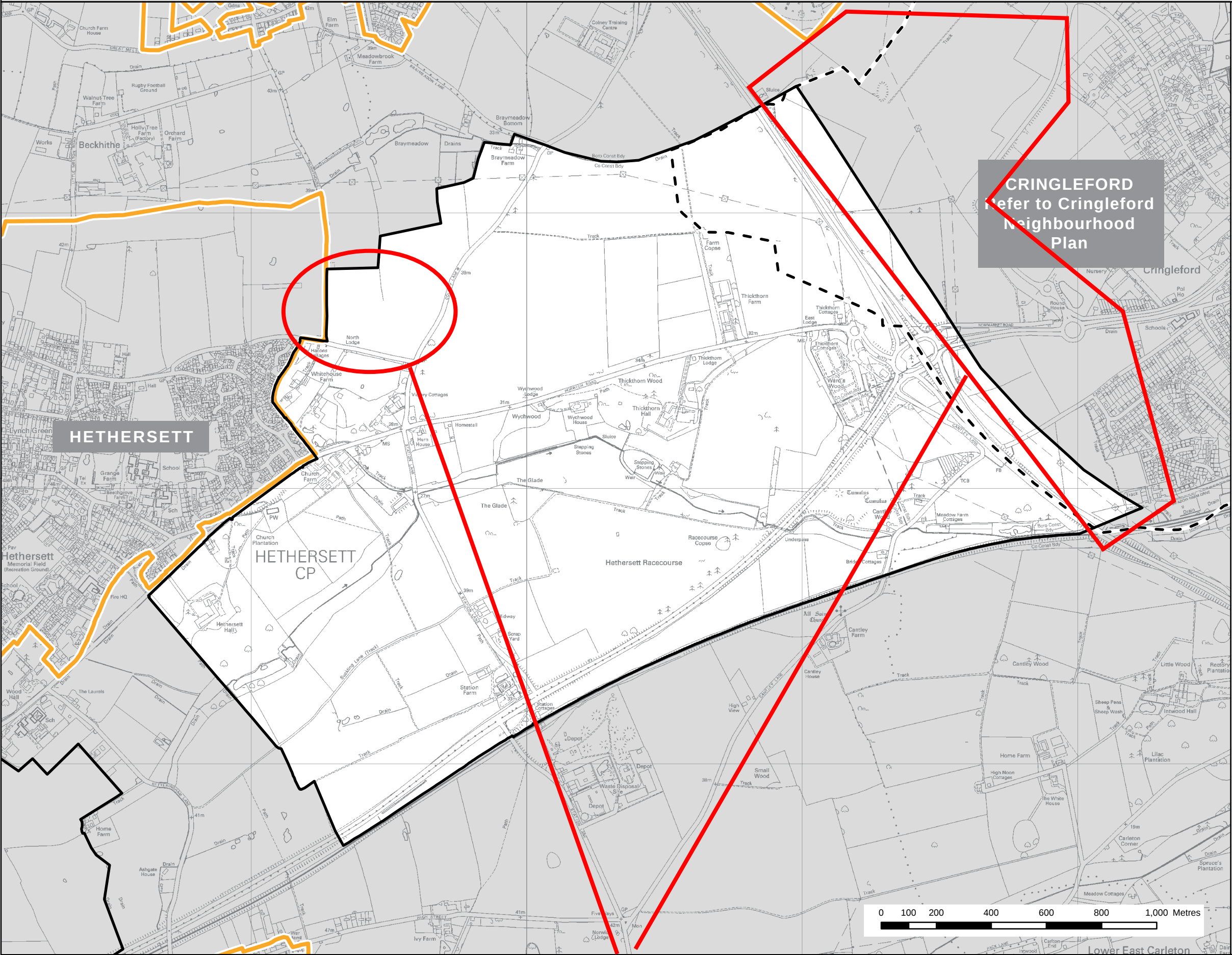

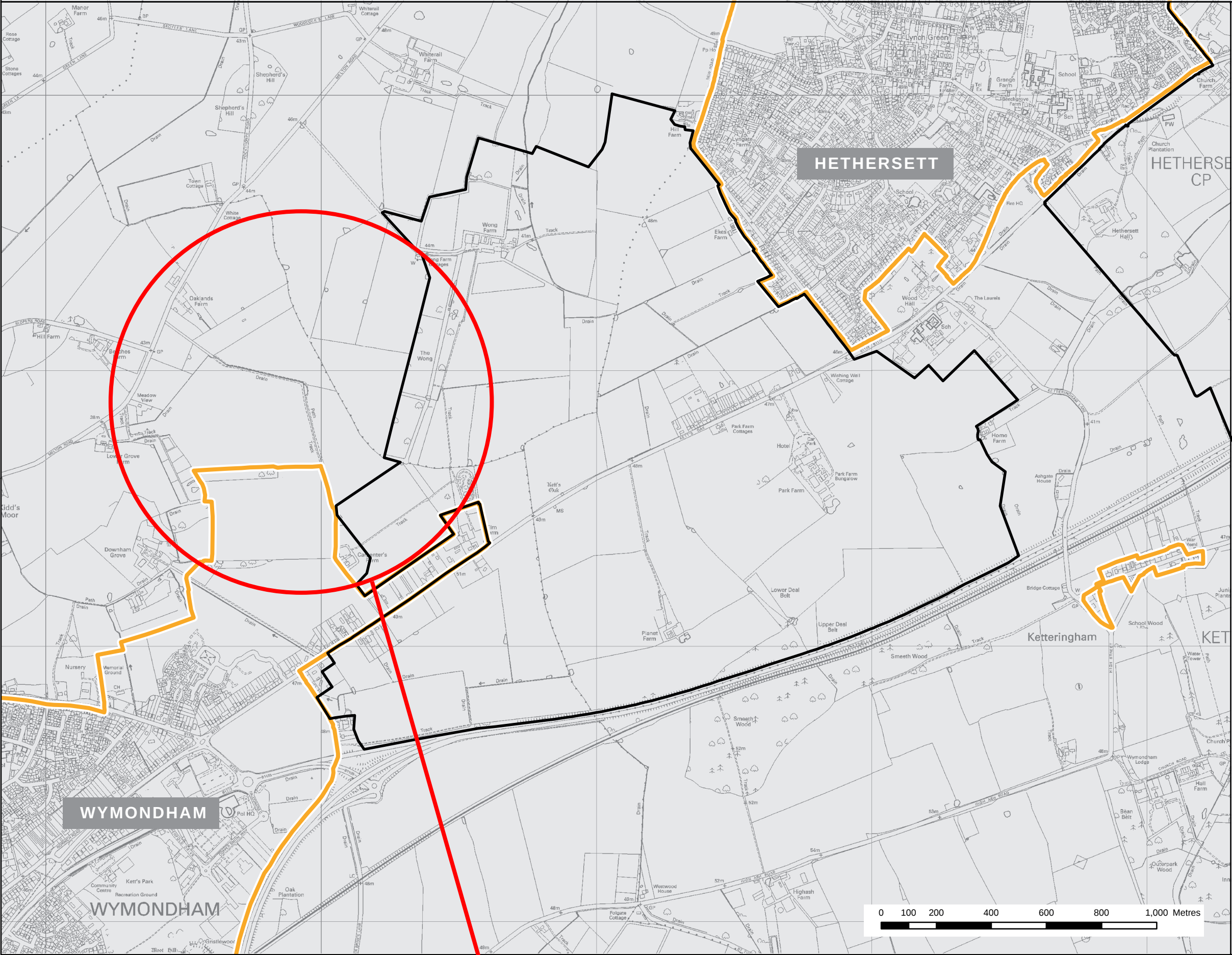
