







THIS CONVEYANCE is made the SEVENTH MARCH . NOW THIS DEED WITNESSETH that in pursuance of the said agreement and in consideration of the sum of Ninety Eight thousand five hundred pounds now paid by the Purchaser to the Vendor (the receipt whereof the Vendor hereby acknowledges) the Vendor as beneficial Owner hereby conveys unto the Purchaser ALL THOSE pieces of freehold land situate in the Parish of Dickleburgh in the County of Norfolk and containing 5.754 acres or thereabouts as the same are more particularly described in the Schedule hereto and are for the purpose of identification only delineated on the plan annexed hereto and thereon edged red TOGETHER with the prefabricated bungalow now standing on part of the Ordnance Survey Parcel Numbered 222 for the said Parish of Dickleburgh EXCEPTING AND RESERVING unto the Vendor and its successors in title owners and occupiers of a field being part of the Parcel Numbered 294 on the said Ordnance Survey Map and edged blue on the said plan and within a period of Eighty years from the date hereof either to I drains for the passage of surface water and foul water and soil through the property hereby conveyed along such routes as the Purchaser or its successors in title may reasonably select and thereafter to inspect maintain an replace the same or with the consent of the Purchaser (which consent shall not be unreasonably refused) to connect to such drainage systems as the Purchaser or its successors in title may construct on the property hereby conveyed PROVIDED ALWAYS that the Vendor shall make good all damage
