

Strumpshaw Neighbourhood Plan (Revised 2025-2045)
Referendum – Information Statement

A Referendum relating to the adoption of the Strumpshaw Neighbourhood Plan (Revised 2025-2045) will be held on 7th May 2026.

The question which will be asked in the Referendum is:

‘Do you want Broadland District Council and the Broads Authority to use the Neighbourhood Plan for Strumpshaw to help them decide planning applications in the neighbourhood area?’

The Referendum area is identified on the attached map.

A person is entitled to vote in the Referendum if on 7th May 2026;

- He or she is entitled to vote in an election of any Ward Councillor of Broadland District Council whose Ward area is in the Referendum area; and
- His or her qualifying address for the election is in the Referendum area. A person’s qualifying address is, in relation to a person registered in the register of electors, the address in respect of which he or she is entitled to be so registered.

The Referendum expenses limit that will apply in relation to the Referendum is £2,362 + £0.059 per elector. The number of persons entitled to vote in the Referendum by reference to which that limit has been calculated is 558 (*figure correct at time of publication*).

The Referendum will be conducted in accordance with procedures which are similar to those used at local government elections.
