Dear Adam Nicholls,

It was agreed at the Parish Council meeting held on the 13<sup>th</sup> March 2017, that Dickleburgh and Rushall Parish Council wished to create a Neighbourhood Plan covering the villages of Dickleburgh and Rushall and all other settlements and areas within the parish boundary (see map).

Please find below a copy of minute 190 confirming the decision to submit an application for a Neighbourhood Plan:

**"190. Report on Neighbourhood Planning** - Cllr. Goodman had circulated a short report outlining the responses to the questionnaire from Fri. 24<sup>th</sup> February, the views were audited; discussion followed as to the next step - Cllr. Adlam agreed to print an A1 map of the two villages; a meeting will be arranged to outline the possible policies – young people, education, planning/housing, highways, conservation, green spaces for example, SNC will be invited to advise; it was also suggested that all streets in the localities will be approached separately for their views; further information to be added to the website; a new email address has been created for comments, ideas/suggestions - called 'dandrneighbourhoodplan,' this will be added to the website

A letter to SNC with accompanying map has been prepared for the Chair to sign, informing SNC formally that the Parish Council are to embark on a Neighbourhood Plan, proposed Clir. Goodman, seconded Clir. Johnson and agreed by all."

Our neighbourhood area will be the whole area within the Parish boundary of Dickleburgh & Rushall and will be known as the "Dickleburgh & Rushall Neighbourhood."

We have consulted widely, over a number of occasions with the different communities within the Parish. We have gained support from all quarters of the Parish to develop and put forward a Neighbourhood Plan.

This area has been chosen for the following reasons:

- It is our natural community
- The residents of the Parish wish to ensure development occurs in line with local needs and with due regard to the local environment, proportionality, local heritage and the conservation of flora, fauna and wild life

The Dickleburgh & Rushall Parish Council is the relevant body making the area application for the purposes of section 61G of the 1990 Act.
