A G R E E M E N T

Under Section 106 of the Town and Country

THIS AGREEMENT is made the 19th day of November One thousand nine hundred and ninety-eight BETWEEN THE BROADS AUTHORITY ("the Authority") of Thomas Harvey House 18 Colegate Norwich NR3 1BQ of the first part and MAY GURNEY HOLDINGS LIMITED ("the Owner") whose registered office is situate at Holland Court The Close Norwich Norfolk of the second part

WHEREAS:-

- (1) The Authority is the local planning authority for the purposes of the Town and Country Planning Act 1990 ("the Act") for the area within which the land shown edged red and coloured green on the attached plan ("the Red Land and "the Green Land" respectively) is situated
- (2) The Owner is the owner in fee simple in possession of the Red Land and the Green Land
- (3) The Owner has made applications to the Authority in accordance with the Act and the Act and Regulations and Orders in force thereunder for listed building consent (reference 5/98/0999) to demolish the building situated on the Red Land in the position shown coloured yellow on the attached plan and known as Boatyard Foremans, Cottage ("the Building") and for planning permission (reference 5/98/0998) to re-erect the Building on the Green Land
- (4) The obligations created by this Deed are planning obligations within the meaning of Section 106 of the Act (as amended)
- (5) The obligations created by this Deed are enforceable by the Authority

N O W THIS DEED WITNESSETH as follows:-

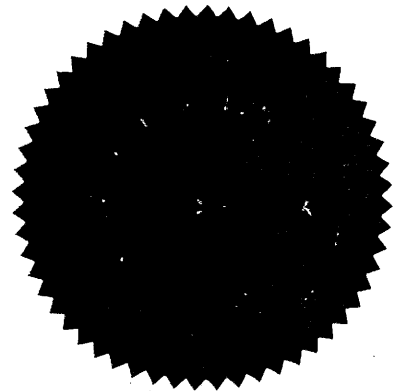
1. This Agreement is made in pursuance of Section 106 of the Act Section 111 of the Local Government Act 1972 and all other enabling powers
2. The Owner hereby covenants with the Authority that in the event of permission and consent being granted in respect of applications references 5/98/0998 and 5/98/0999
 - (i) if they demolish the building pursuant to the consent granted in respect of application reference 5/98/0999 they will re-erect the Building on the Green Land in accordance with the planning permission granted under reference 5/98/0998 within 12 months from the date of this Agreement
 - (ii) following the re-erection of the Building they will not cause or permit it to be demolished or altered or for any alteration to be made within a ten metre margin around the Building as shown in blue on the attached plan without the prior written consent of the Authority
3. This document is executed as a Deed and is delivered on the day and year first before written
4. The expressions "the Authority" and "the Owner" shall include their respective successors and assigns as appropriate within the terms of Section 106 of the Act
