

THIS DEED is made the *Eleventh* day of *November* 1987 BETWEEN BROADLAND DISTRICT COUNCIL of Thorpe Lodge Yarmouth Road Norwich Norfolk (hereinafter called 'the Council') of the first part and DRAYTON FARMS LIMITED whose registered office is at 7 The Close Norwich Norfolk (hereinafter called 'Drayton Farms') of the second part R. G. CARTER LIMITED whose registered office is at Drayton, Norfolk (hereinafter called 'Carter') of the third part and ROY ARTHUR BURTON of Woodlands Brick Kiln Road Hevingham Norfolk (hereinafter called 'Mr. Burton') of the fourth part.

WHEREAS

I This Deed is supplemental to an Agreement dated the 14th day of March 1984 and made between the Council of the one part and Drayton Farms of the other part (hereinafter called 'The Agreement').

II Drayton Farms is now seized in fee simple absolute in possession of the land shown crosshatched red on the plan annexed hereto.

III Carter is now seized in fee simple absolute in possession of the land shown edged red but not hatched on the plan annexed hereto.

IV Mr. Burton is now seized in fee simple absolute in possession of the land shown hatched red on the plan annexed hereto.

V The plan annexed to the Agreement did not accurately delineate the eastern boundary of the area referred to in that Agreement as Phase 2.

VI Since the entry to the Agreement the parties hereto have agreed that further areas of land shown be included in Phase 2 of the development referred to in the Agreement.

NOW THIS DEED WITNESSETH as follows:

1. FROM the date hereof and at all times hereafter the Agreement shall be read and construed and take effect as though Phase 2 was the area shown edged red and partly unhatched partly hatched red and partly cross hatched red on the plan annexed hereto and not the area described as such Phase 2 in the Agreement.
2. IN all other respects the Parties hereto confirm the Agreement.

IN WITNESS where of the Council Drayton Farms and Carter here caused their respective Common Seals to be affixed hereto and Mr. Burton has set his hand and seal hereto the day and year first before written.

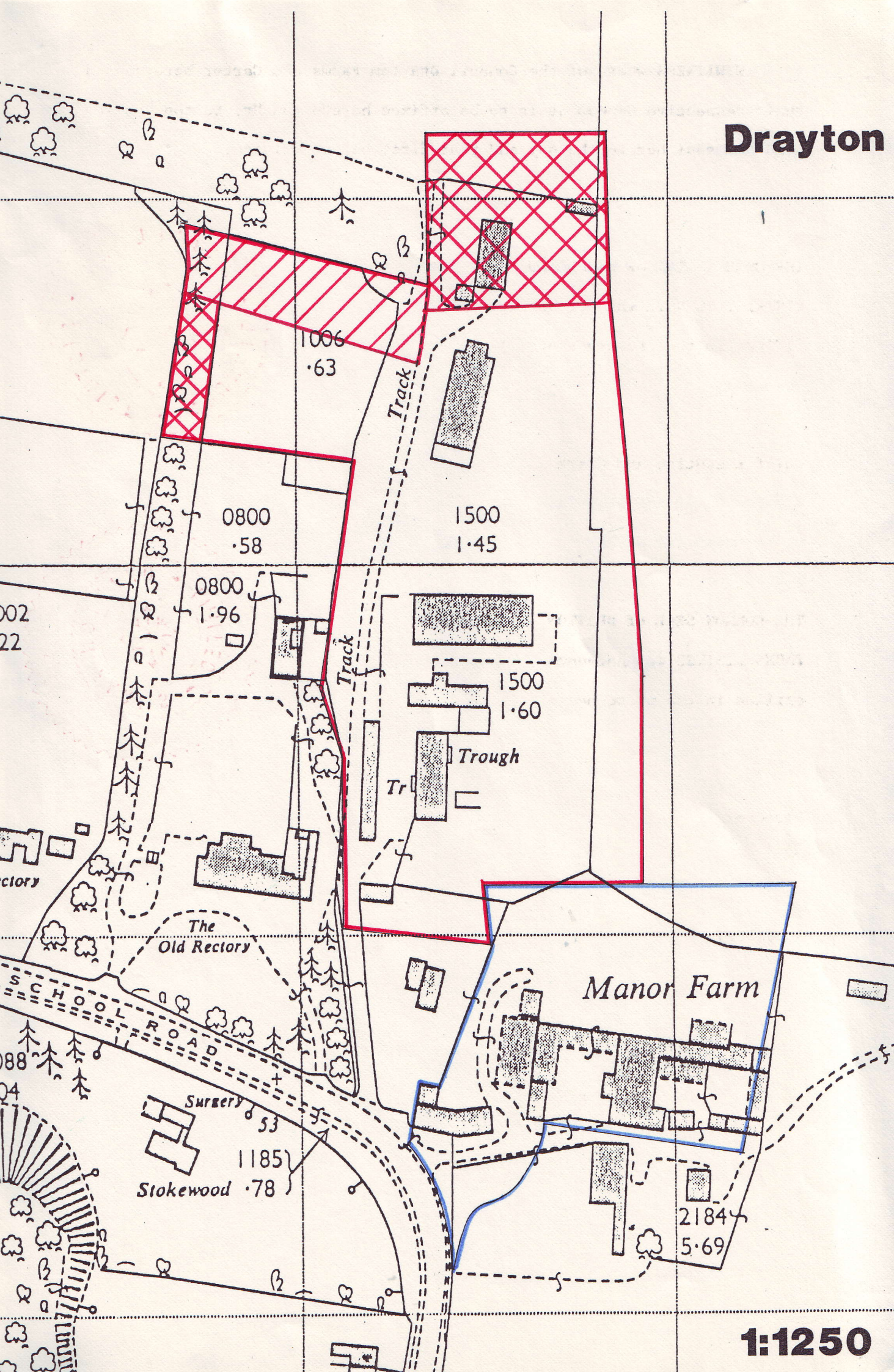

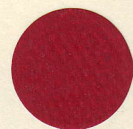
