DECLARATIONS OF INTEREST AT MEETINGS

When declaring an interest at a meeting Members are asked to indicate whether their interest in the matter is pecuniary, or if the matter relates to, or affects a pecuniary interest they have, or if it is another type of interest. Members are required to identify the nature of the interest and the agenda item to which it relates. In the case of other interests, the member may speak and vote. If it is a pecuniary interest, the member must withdraw from the meeting when it is discussed. If it affects or relates to a pecuniary interest the member has, they have the right to make representations to the meeting as a member of the public but must then withdraw from the meeting. Members are also requested when appropriate to make any declarations under the Code of Practice on Planning and Judicial matters.


If yes, you need to inform the meeting. When it is discussed, you will have the right to make representations to the meeting as a member of the public but you should not partake in general discussion or vote.

ELECTORAL ARRANGEMENTS REVIEW COMMITTEE

Minutes of a meeting of the Electoral Arrangements Review Committee of South Norfolk District Council held at South Norfolk House, Long Stratton on 14 August 2018 at 10:30am.

Committee Members Present: Councillors: C Kemp (Chairman), C Easton, K Kiddie and T Lewis

Apologies: Councillors: J Fuller and L Hornby

Substitute Members: Councillors: M Edney for J Fuller and A Thomas for L Hornby

Officers in Attendance: The Electoral Services Manager (J Tovee-Galey) and the Electoral Services Officer (N Tullock).

31. MINUTES

The minutes of the Electoral Arrangements Review Committee held on 29 November 2017 were confirmed as a correct record and signed by the Chairman.

Regarding the changes made to the boundary of Bixley, Caistor St Edmund and Poringland, Cllr Lewis stated that he was unhappy with the outcome as he felt it would have been more logical for the area around Octagon Farm to have been moved into Framingham Earl rather than Poringland. He advised members that, although he understood that the Committee's recommendations had been approved by Full Council and formed part of the Order, he regretted that he had not spotted the issue when the Committee had considered its recommendations using the maps provided. Members noted that the Council had recently appointed a Geographic Information Systems (GIS) Analyst so future graphics would be more detailed. The Electoral Services Manager advised that, for future Community Governance Reviews, it might be advantageous for the Committee to consider the District in several smaller parts.

32. POLLING DISTRICTS AND POLLING PLACES REVIEW 2018

The Electoral Services Manager presented her report, advising members that, following the amendment of some parish boundaries as a result of the Community Governance Review, it had been necessary to undertake an interim Polling Districts and Polling Places Review to ensure that suitable and convenient polling arrangements were in place for the May 2019 District and Parish Elections. Members were pleased to note that town and parish councils had been consulted with positive responses received, as detailed in the report.

The Chairman invited members to consider each of the proposed polling district amendments and polling places, as detailed in the report, noting that, if agreed, the changes would be incorporated in time for the May 2019 District and Parish Elections but that there would be a further opportunity to review these again at the end of 2019.

The Committee highlighted potential practical issues regarding the proposal to move the polling station for Tharston residents to Hapton. Members were concerned that the high numbers of Tharston residents, who would need to travel by car, would encounter parking and turning problems in the village. Cllr Thomas suggested that she approach the owner of Picton Farm to try to alleviate the problems with lighting and obstructions in the building. The Committee agreed that, should the venue be improved, it could remain as a polling place for Tharston residents, with a further review being carried out at the end of 2019.

Members noted that an additional Polling District was required for the Parliamentary Election for those electors who were moved from Hethersett into Little Melton and those who were moved from Old Costessey into New Costessey West, following the Governance Review. The Committee also noted that a new Polling District was required for a County Election for those electors who were moved from Bawburgh into Old Costessey. In response to a member's question, the Chairman clarified that although the Council would have a role in the County Boundary Review, this would be on a merely consultative/advisory basis.

It was noted that many of the issues raised by Polling Station Inspectors were minor and could be resolved by the Council working with venue managers. It was then

RESOLVED:

To agree that, with effect from 1 December 2018:

1. the polling district amendments as indicated in Appendix 1 and Maps 1-12 be implemented;
2. the polling places as indicated in Appendix 1 be approved, with the exception of Tharston and Hapton (Reference SU1) where Picton Farm would remain as the Polling Place for Tharston residents, should the venue be improved;

and
3. the Returning Officer retain delegation of alternative polling places, should the designated polling place and therefore polling station be unavailable.

33. PARTICIPATION IN VOTER ID PILOT SCHEME 2019

Members considered the report of the Electoral Services Manager which detailed the request from the Cabinet Office for district councils to take part in a proposed Voter ID Pilot in relation to the scheduled District and Parish elections on 2 May 2019. It was noted that the Council had expressed an interest in taking part in the pilot scheme and that the Cabinet Office had originally required formal applications by 31 August, although this had since been extended to 10 September 2018.

The Committee discussed the list of ID requirements contained in the report and noted that if a resident did not bring their poll card to the polling station and could not produce any of the ID listed, their identity could be attested. Members agreed that it would be inappropriate for a poll clerk to be permitted to verify a resident's identity.

During discussion, members stressed the importance of effective communication between the Council and the electorate, confirming that correspondence should be clearly marked to alert residents that poll cards should be taken to the polling station.

In response to concerns raised around the requirement for poll cards to be barcoded so they could be scanned at the polling station and the extra resources required to facilitate the process, officers confirmed that funding for the costs of

piloting the scheme would be met by the Cabinet Office. The Electoral Services Manager also confirmed that staffing levels for administering election work were currently being addressed and these should be sufficient to enable the Council to undertake the pilot, but added that if the Council agree to take part in the pilot and she did not have confidence that adequate resources were in place, she would request that SNC withdraw from the process.

A brief discussion followed during which members endorsed the Council's application to pilot the scheme, with future arrangements to be delegated to the Electoral Services Manager in consultation with Cllrs C Kemp, K Kiddie and T Lewis. It was also suggested and agreed that, if no significant issues arose, there was no requirement for the Electoral Arrangements Review Committee to consider the item further.

It was then

RESOLVED:

To endorse the Council's application to pilot the Voter ID Scheme 2019 and, if no significant issues arise, future arrangements be delegated to the Electoral Services Manager in consultation with Cllrs C Kemp, K Kiddie and T Lewis.

Review of Polling Districts, Polling Places and Polling Stations 2019.

Purpose of the Report:

To comply with legal requirements to undertake a review of Polling Districts and Polling Places. The statutory purpose of the review is to ensure that suitable and convenient polling arrangements are provided for local electors. The amendment of some parish boundaries by the Community Governance Review forced an interim review of Polling Districts and Polling Places in 2018. However, this interim review was on the basis that a full review would be undertaken in 2019.

Recommendations:

1. Polling districts should remain unaltered as there have been no changes which require any amendments (since those changes implemented in 2018).
2. Polling places should be amended as listed in Appendix 1.

1 SUMMARY

- 1.1 Review the polling districts and polling places to ensure that suitable and convenient polling arrangements are provided for local electors.

2 BACKGROUND

- 2.1 A District Ward Review was undertaken by the Local Government Boundary Commission for England in 2017/2018. This made changes to the district wards and to the parish wards in Wymondham, Costessey, and Bawburgh.
- 2.2 South Norfolk Council undertook a Community Governance Review in 2017 which changed some parishes and ward boundaries. As a result of these boundary changes, applications for related alterations were submitted and agreed by the Local Government Boundary for England to amend a district ward and county division.
- 2.3 The Electoral Registration and Administration Act 2013 Section 17 requires local authorities to review Polling Districts and Polling Places within 16 months of 1 October 2013 and then every fifth year after that.
- 2.4 In conducting the review, the Council must demonstrate that it has (as far as is practicable), met the criteria set out in legislation. Those criteria are:
- a) Each parish in England is to be a separate polling district, unless special circumstances apply.
 - b) The Council must designate a polling place for each polling district, unless the size or other circumstances of a polling district are such that the situation of polling place does not materially affect the convenience of the electors.
 - c) The polling place must be an area in the polling district, unless special circumstances make it desirable to designate an area wholly or partly outside the polling district (for example, if no accessible polling place can be identified in the polling district)
 - d) The polling place must be small enough to indicate to electors in different parts of the polling district how they will be able to reach the polling station.
- 2.5 In addition, the Council must also seek to ensure that:
- a) electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances.
 - b) as far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors and when considering the designation of a polling place, must have regard to the accessibility needs of disabled persons.
- 2.6 In an ideal world, an authority would have a choice of a range of fully accessible buildings which are conveniently located for the electors in each area. However, the Electoral Commission recognizes that, in practice, this is frequently not the case and there may actually be little choice available (particularly in rural areas).

- 2.7 The Commission also recognizes that the choice of polling place will often be a balance between the quality (access, facilities, etc.) of a building and the distances between the residents and that building compared to other options. Where it is unavoidable to use a polling place where access is not ideal, the Commission expects a Council to make reasonable adjustments to provide access for all electors.
- 2.8 There is no specified method on how to balance and compromise the relevant circumstances of each polling district and polling place. However, the Council needs to be able to show that they followed a reasonable and consistent methodology in arriving at its choice.

3 CURRENT POSITION

- 3.1 The District Ward Review by the Local Government Boundary Commission for England, and the Community Governance Review and Interim Review of Polling Districts and Polling Places undertaken by South Norfolk Council led to changes to both polling districts and polling places.
- 3.2 Details of the current polling districts and polling places can be seen in Appendix 1 (Appendix 1 also includes comments from the 2019 elections and the Acting Returning Officer 's comments and proposals).
- 3.3 The Returning Officer currently has delegated power to designate alternative polling places if necessary, where circumstances do not allow for the matter to be decided otherwise.

4 FINDINGS AND PROPOSED ACTION

- 4.1 As part of this Review, consultation has been undertaken for five weeks (finishing on 31 July 2019). Information relating to the Review was published on the Council's website. local Members of Parliament, District and County councillors, parish and town councils, and political parties with previous involvement in South Norfolk were specifically consulted.
- 4.2 Responses received are listed in Appendix 1.
- 4.3 The available information and the relevant circumstances of each polling district and polling place identified in the Review have been considered.
- 4.4 The conclusion of the Review in respect of polling districts is that they should remain unchanged. The information available does not indicate that any meaningful improvement can be made by changes at this time.
- 4.5 The conclusion of the Review in respect of polling places is that changes (as listed in Appendix 1) should be made to a limited number of polling places.

- 4.3 Finally, the Returning Officer should retain delegated authority to designate an alternative polling place as necessary when circumstances do not allow for the matter to be decided otherwise.

5 ISSUES AND RISKS

- 5.1 Polling districts and polling places must be designated in accordance within the relevant legislation.
- 5.2 **Resource Implications** – Increasing or decreasing the number of polling places changes the cost of elections or referendums undertaken and affects the District elections budget.
- 5.3 **Legal Implications** – polling districts, polling places and polling stations must be designated in accordance within the relevant legislation. Failure to do so will leave the Council vulnerable to challenge and will prejudice its statutory duty in respect of elections.
- 5.4 **Equality Implications** – The Council has a statutory duty general and specific to ensure that (as far as reasonable and practicable) every polling place and polling station is accessible to electors.
- 5.5 **Environmental Impact** – No implications identified.
- 5.6 **Crime and Disorder** – No implications identified.
- 5.7 **Risks** – No other risks have been identified.

6 CONCLUSION

- 6.1 The previous amendments to polling districts made in 2018 appear to have been successful and no further possible improvements have been identified.
- 6.2 As a result of the information available to the Review, several polling places should be amended as listed in Appendix 1.

7 RECOMMENDATIONS

- 7.1 The Electoral Arrangements Committee are asked to agree to the following to take effect immediately
- a) Polling district to remain unchanged.
 - b) Polling places to be amended as listed in Appendix1.
 - c) The Returning Officer to retain delegated authority to designate alternative polling places in emergencies.
