**SOUTH NORFOLK LOCAL PLAN – DEVELOPMENT MANAGEMENT POLICIES DOCUMENT –  
ADOPTION STATEMENT**

In accordance with Regulations 26 and 35 of the Town and Country Planning (Local Planning) (England) Regulations 2012, and Regulation 16 of the Environmental Assessment of Plans and Programmes Regulations 2004, **NOTICE IS HEREBY GIVEN** that the South Norfolk Local Plan – Development Management Policies Document (DMPD) and accompanying Local Plan Policies Map updates was formally adopted by South Norfolk Council on 26<sup>th</sup> October 2015. The adoption followed a resolution passed at the meeting of Full Council on 19<sup>th</sup> October 2015 to adopt the DMPD with effect from 26<sup>th</sup> October 2015.

The DMPD (along with the Site Specific Allocations & Policies Document and Wymondham Area Action Plan, which were also adopted on 26<sup>th</sup> October 2015, and which have their own Adoption Statements) replaces almost all of the 'saved' policies of the 2003 South Norfolk Local Plan. The DMPD sets out district-wide policies to guide development and change in South Norfolk for the period to 31 March 2026.

The DMPD was subject to examination by an independent Inspector, appointed by the Secretary of State. The Inspector's Report (received on 28<sup>th</sup> September 2015) concluded that, with a number of main modifications, the DMPD is capable of adoption. Pursuant to section 23 (3) of the Planning and Compulsory Purchase Act 2004 (the Act), all the Inspector's recommended modifications to the Regulation 19 (of the Town and Country Planning (Local Development) (England) Regulations 2012) draft DMPD (see Appendices 1 and 2 of the Inspector's Report) have been incorporated into the adopted DMPD along with additional (minor) modifications made by South Norfolk Council.

Any person aggrieved by the adoption of the DMPD may make an application to the High Court under Section 113 of the Planning and Compulsory Purchase Act 2004 on the grounds that the document is not within the appropriate powers conferred by Part 2 of the Planning and Compulsory Purchase Act 2004 or that a procedural requirement of the Planning and Compulsory Purchase act 2004 or its associated Regulations has not been complied with. Any such application must be made and recorded as received no later than six weeks after the date of adoption by the Council, namely 7<sup>th</sup> December 2015.
