Minutes of a meeting of South Norfolk District Council held at South Norfolk House, Long Stratton on Monday 14 May 2018 at 7.30pm

#### 3434 CHAIRMAN'S ENGAGEMENTS

The Chairman explained that it had been both an honour and a privilege to have represented the Council at the numerous engagements he had attended throughout the year. He thanked members for their support in what had been a most enjoyable year.

The Chairman also expressed his appreciation for the help and support he had received from officers, giving special mention to the Chief Executive, and the Democratic Services Team Leader.

#### 3435 APPOINTMENT OF CHAIRMAN OF THE COUNCIL FOR 2018/19

Cllr V Thomson proposed, seconded by Cllr P Hardy, that Cllr J Overton be appointed Chairman of the Council for the ensuing municipal year.

In the absence of other nominations, *it was RESOLVED* that Cllr J Overton be elected Chairman of the Council for 2018/19. Cllr Overton took the Chair and signed the Declaration of Acceptance of Office.

#### 3436 APPOINTMENT OF VICE-CHAIRMAN OF THE COUNCIL FOR 2018/19

Cllr T Palmer proposed, seconded by Cllr K Kiddie, that Cllr G Minshull be appointed Vice- Chairman of the Council for the ensuing municipal year.

In the absence of other nominations, it was RESOLVED that Cllr G Minshull be elected Vice-Chairman of the Council for 2018/19.

Cllr Minshull felt it an honour to have been appointed as Vice-Chairman, and he looked forward to assisting the Chairman throughout the coming year.

#### 3437 ELECTION OF LEADER OF THE COUNCIL FOR 2018/19

Cllr J Hornby proposed, seconded by Cllr A Pond, that Cllr J Fuller be appointed Leader of the Council for the ensuing municipal year. In the absence of other nominations, *it was RESOLVED* that Cllr J Fuller be elected Leader of the Council for 2018/19.

Cllr Fuller was disappointed to report that Cllr L Hornby had decided to step down from the Cabinet, due to other commitments. He paid tribute to Cllr Hornby's service on the Cabinet, and referred to his level headed and fair approach. He was, however, pleased that Cllr L Neal had accepted his invitation to replace Cllr Hornby as a Cabinet member.

Cllr Fuller went on to explain that he had made small modifications to the portfolios. Members noted that Cllr Mason Billig's portfolio "Environment and Recycling" would now include Shared Services, and was renamed "Shared Services, Waste and Recycling". The Regulation and Public Safety Portfolio would now include Community Protection and Environmental Quality.

#### 3438 VOTE OF THANKS TO RETIRING CHAIRMAN

Cllr J Fuller paid tribute to Cllr B Duffin's service as the Chairman of the Council for 2017/18, and also Cllr Duffin's wife, Pam, who had been his constant companion throughout his many engagements. He referred to Cllr Duffin's commitment, enthusiasm and hard work, and gave mention to numerous events Cllr Duffin had attended throughout the year.

Cllr V Bell also thanked Cllr Duffin for his service to both members and residents throughout the year. She referred to his polite nature, and his fair and even-handed approach to all throughout his term of office.

#### **3439 MINUTES**

The minutes of the meeting held on Monday 16 April 2018, were agreed as a correct record, and signed by the Chairman.

### 3440 CHAIRMAN'S ANNOUNCEMENTS

The Chairman announced his chosen charities for the year ahead; It's On the Ball, a charity supporting patients with testicular cancer, and Cancer Research UK.

The Chairman stressed that he felt it an honour to be appointed as Chairman of the Council, and he looked forward to the year ahead.

#### 3441 MONITORING OFFICER REPORT

Cllr J Fuller presented the report of the Monitoring Officer, regarding the allocation of seats on committees, member appointments on committees for 2018/19, and a number of proposed amendments to the constitution. Members also noted the addendum to the report (emailed separately to members), regarding required constitutional amendments to the current scheme of delegation of functions to officers relating to the Licensing Act 2003.

Cllr Fuller briefly outlined the report proposals to Council.

During discussion, he referred members to the revised Appendix 2, tabled at the meeting, detailing the proposed appointments of Chairmen of Committees for 2018/19. As in previous years, he suggested that individual member appointments to committees be delegated to Group Leaders, and advised at a later date. He drew members' attention to Appendix 1 of the report and members noted that a correction was required under the Community Action Fund Panel. The Portfolio holder for Stronger Communities was a member of the Panel, and not the Portfolio holder for Housing, Wellbeing, Leisure and Early Intervention, as had been indicated in the agenda.

Referring to the proposal to reduce the number of seats on the Development Management Committee, Cllr Fuller explained that he believed that this would create a more stable cohort of trained and knowledgeable members, which would improve consistency and reduce the reliance on substitutes. In response, Cllr T Lewis expressed his disappointment that this would reduce the number of Liberal Democrat seats from two, to one. He also expressed concern at Cllr Fuller's reasons for change, explaining that he felt this gave out a negative message regarding the quality of the members on the Committee. He doubted that a reduction in numbers would improve the quality of decision making and he stressed that the Liberal Democrats would continue to contribute positively to the meetings.

Members agreed that the final appointments should be delegated to the Leader of the Council, in consultation with the Leader of the Opposition. Cllr Fuller explained that he did not intend to make many changes, and that he would consider any requests from members. Cllr T Lewis added that should representation become available on the Norfolk Rivers Internal Drainage Board, a member of his Group would be happy to take on the role.

#### 3443 ANNUAL REPORTS / QUESTIONS TO CHAIRMEN AND PORTFOLIO HOLDERS

#### a) Cabinet

Cllr K Kiddie drew members' attention to an announcement made that very morning of Government investment of £40 m in the Quadram Institute, at the Norwich Research Park. Cllr Fuller hailed this as a real success story for the District, reminding members that the growing economy continued to be a priority for the Council.

Cllr T Lewis asked whether the caterers at the South Norfolk House canteen could reconsider the use of disposable coffee cups. Cllr K Mason Billig welcomed this suggestion, explaining that staff were encouraged to recycle wherever possible, however, the practicalities of this proposal would need to be further explored. Cllr Fuller suggested that the Growth, Investment and Environment Policy Panel could look in to the matter further.

Cllr N Legg asked Cllr Y Bendle, whether the necessary funds had been secured to ensure that the District Direct Hospital Partnership Scheme could continue to run for a further year. Cllr Bendle reminded members of the background and purpose of the scheme. She explained that the scheme would run for at least a further year, with the necessary funding being obtained from Adult Social Care and the three Clinical Commissioning Groups, and negotiations were currently taking place with the other four participating councils.

Cllr M Edney referred to the Council's GEMs awards that had taken place the previous week. He wished to convey his thanks to all those involved, including the Leader of Sevenoaks Council, who had co-hosted the event. He was sure that all would agree that it had been an excellent evening.

### b) Scrutiny Committee

Members referred to the annual report of the Scrutiny Committee. Cllr G Minshull thanked the Scrutiny Officer, Emma Goddard, for her work throughout the year.

### c) Annual Report of the Finance, Resource, Accounts and Governance Committee

Members noted the annual report of the Finance, Resource, Accounts and Governance Committee.

The Chairman, Cllr P Hardy, made reference to some useful training forums that he had recently attended, and explained that he would be providing feedback to members at the next meeting of the Committee.

### d) Licensing Appeals and Complaints Committee /Licensing and Gambling Acts Committee

There were no questions to the Chairman of the Licensing Committee.

The Chairman, Cllr D Goldson, thanked David Neville, the Housing and Benefits Team Leader officer, and all those who had attended the recent member briefing session on changes to the XX Act. He stressed the importance of members of the Committee keeping their accreditation up to date, so that there was an even spread of members participating in Panel meetings

## e) Development Management Committee

There were no questions to the Chairman of the Development Management Committee.

The Chairman, Cllr V Thomson, made brief reference to the joint working in the Planning at South Norfolk and Broadland, explaining that it was progressing well.

### f) Electoral Arrangements Review Committee

There were no questions to the Chairman of the Electoral Arrangements Review Committee

Cllr Kemp informed members that the Committee would shortly be considering a review of Polling Districts and Polling Places

#### 3444 OUTSIDE BODIES

Cllr C Kemp referred to his report regarding the Police and Crime Panel for Norfolk. He drew attention to his suggestion for a presentation of the Business Case to transfer the governance of the Fire and Rescue Service from Norfolk County Council to the Local Commissioner, at a meeting of the Scrutiny Committee, and this approach was endorsed by Cllr T Lewis. Cllr Kemp also explained that Norfolk County Council may issue an alternative business case, seeking to retain the service.

Cllr V Thomson drew attention to the recent Peer Review of the Broads Authority, which had raised issues of governance and stake holder involvement. He was disappointed that not much progress had been made, however, a meeting had been scheduled for later that week to discuss the issues.
