### **DECLARATIONS OF INTEREST AT MEETINGS**

When declaring an interest at a meeting Members are asked to indicate whether their interest in the matter is pecuniary, or if the matter relates to, or affects a pecuniary interest they have, or if it is another type of interest. Members are required to identify the nature of the interest and the agenda item to which it relates. In the case of other interests, the member may speak and vote. If it is a pecuniary interest, the member must withdraw from the meeting when it is discussed. If it affects or relates to a pecuniary interest the member has, they have the right to make representations to the meeting as a member of the public but must then withdraw from the meeting. Members are also requested when appropriate to make any declarations under the Code of Practice on Planning and Judicial matters.

Have you declared the interest in the register of interests as a pecuniary interest? If Yes, you will need to withdraw from the room when it is discussed.

Does the interest directly:

- 1. affect yours, or your spouse / partner's financial position?
- 2. relate to the determining of any approval, consent, licence, permission or registration in relation to you or your spouse / partner?
- 3. Relate to a contract you, or your spouse / partner have with the Council
- 4. Affect land you or your spouse / partner own
- 5. Affect a company that you or your partner own, or have a shareholding in

If the answer is "yes" to any of the above, it is likely to be pecuniary.

Please refer to the guidance given on declaring pecuniary interests in the register of interest forms. If you have a pecuniary interest, you will need to inform the meeting and then withdraw from the room when it is discussed. If it has not been previously declared, you will also need to notify the Monitoring Officer within 28 days.

Does the interest indirectly affect or relate any pecuniary interest you have already declared, or an interest you have identified at 1-5 above?

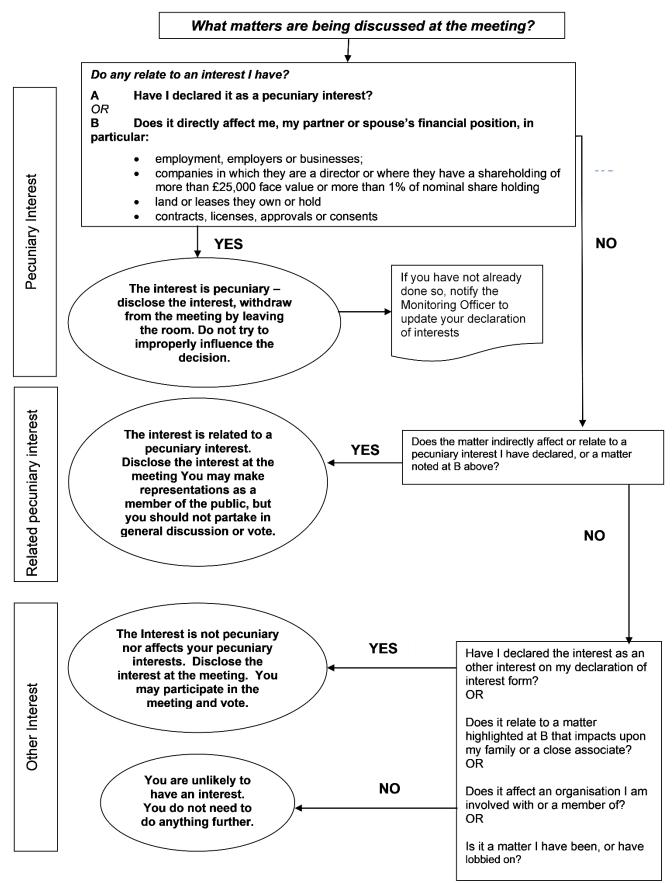
If yes, you need to inform the meeting. When it is discussed, you will have the right to make representations to the meeting as a member of the public, but you should not partake in general discussion or vote.

Is the interest not related to any of the above? If so, it is likely to be an other interest. You will need to declare the interest, but may participate in discussion and voting on the item.

Have you made any statements or undertaken any actions that would indicate that you have a closed mind on a matter under discussion? If so, you may be predetermined on the issue; you will need to inform the meeting, and when it is discussed, you will have the right to make representations to the meeting as a member of the public, but must then withdraw from the meeting.

### 51 APOLOGIES FOR ABSENCE

Apologies for absence were received from Councillors S Beadle, A Crotch, N Harpley and D King.

### 52 MINUTES

The minutes of the meeting held on 7 June 2021 were agreed as a correct record and signed by the Chairman.

### 53 EXCLUSION OF THE PRESS AND PUBLIC

#### **RESOLVED:**

### 54 AWARD OF CONTRACT – BURE VALLEY RAILWAY FENCING

Members considered the exempt report of the Community Assets Manager which was inviting the Panel to recommend that the Cabinet award the contract for work to the fencing along the Bure Valley Railway. Following discussion, during which officers answered members' questions and undertook to clarify the arrangements for funding the project in the report to Cabinet, it was

### **RESOLVED to recommend Cabinet:**

- 1 to agree the award of the contract for the replacement of the boundary fence as set out in the exempt minutes;
- 2 subject to rewording of the funding arrangements, to approve the use of reserves to fund the improvements on the Bure Valley Railway for the purpose of installing a boundary fence.

### 55 PROPOSAL FOR A SECOND BUILDING AT THE FOOD ENTERPRISE PARK

Members considered the exempt report of the Growth Delivery Manager regarding a proposal for a second building at the Food Enterprise Park.

Following discussion, during which officers answered members' questions, it was

to agree to the proposals and the detailed recommendations as set out in the exempt minutes and at paragraph 1 of the report (noting that the recommendations set out in paragraph 9 of the report needed to be aligned with the correct recommendations at paragraph 1.)

Members considered the work programme and, following discussion, the following amendments were noted:

- 22 November 2022 options for ongoing management of streetlights reference to "Broadland" be changed to "Drayton";
- Consideration of the Broadland Country Park Masterplan be brought forward from the April 2022 meeting to the current financial year (31 January 2022 meeting) to facilitate earlier implementation of any proposals but the option for the January meeting to be moved to early February be explored as January was too early;
- Consideration be given to adding Skills and Training and Apprenticeships to the future work programme.
