THE SECOND SCHEDULE REFERRED TO THE CONDITIONS

The development which is the subject of Planning Application Number 80.1176.F shall be commenced within one month of the commencement of demolition of the three cottages presently situated upon the property referred to in Schedule 1 hereof the said cottages being the same as those referred to in an application for Listed Building Consent made by the Owner to the Council under reference number 79.3179.LB.
- 2. The development which is the subject of Planning Application Number 80.1176.F shall be completed within thirteen months of the commencement of demolition of the cottages referred to in Condition 1 above.
