

# TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1988

## DIRECTION RESTRICTING PERMITTED DEVELOPMENT

WHEREAS THE SOUTH NORFOLK DISTRICT COUNCIL being the appropriate local planning authority within the meaning of articles 4 and 5 of the Town and Country Planning General Development Order 1988 (hereinafter called "the Order" are of the opinion that development of the description set out in the Schedule hereto should not be carried out on land at 25, 27, 29, 31, 33, 35 Friarscroft Lane, Wymondham, Norfolk being the land shown edged red on the plan annexed hereto unless permission therefore is granted on application made under the Order.

AND WHEREAS the Council are further of the opinion that development of the said description would constitute a threat to the amenities of the area and that the provisions of paragraph 4 of article 5 of the Order thus applies to this direction.

NOW THEREFORE the said Council in pursuance of the power conferred upon them by the said articles 4 and 5 hereby direct that the permission granted by article 3 of the Order shall not apply to development on the said land of the description set out in the Schedule hereto.

THIS DIRECTION is made in pursuance of the provisions of paragraph 4 of article 5 of the Order and shall remain in force until 29th October 1994 (being six months from the date of this direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date.

### SCHEDULE

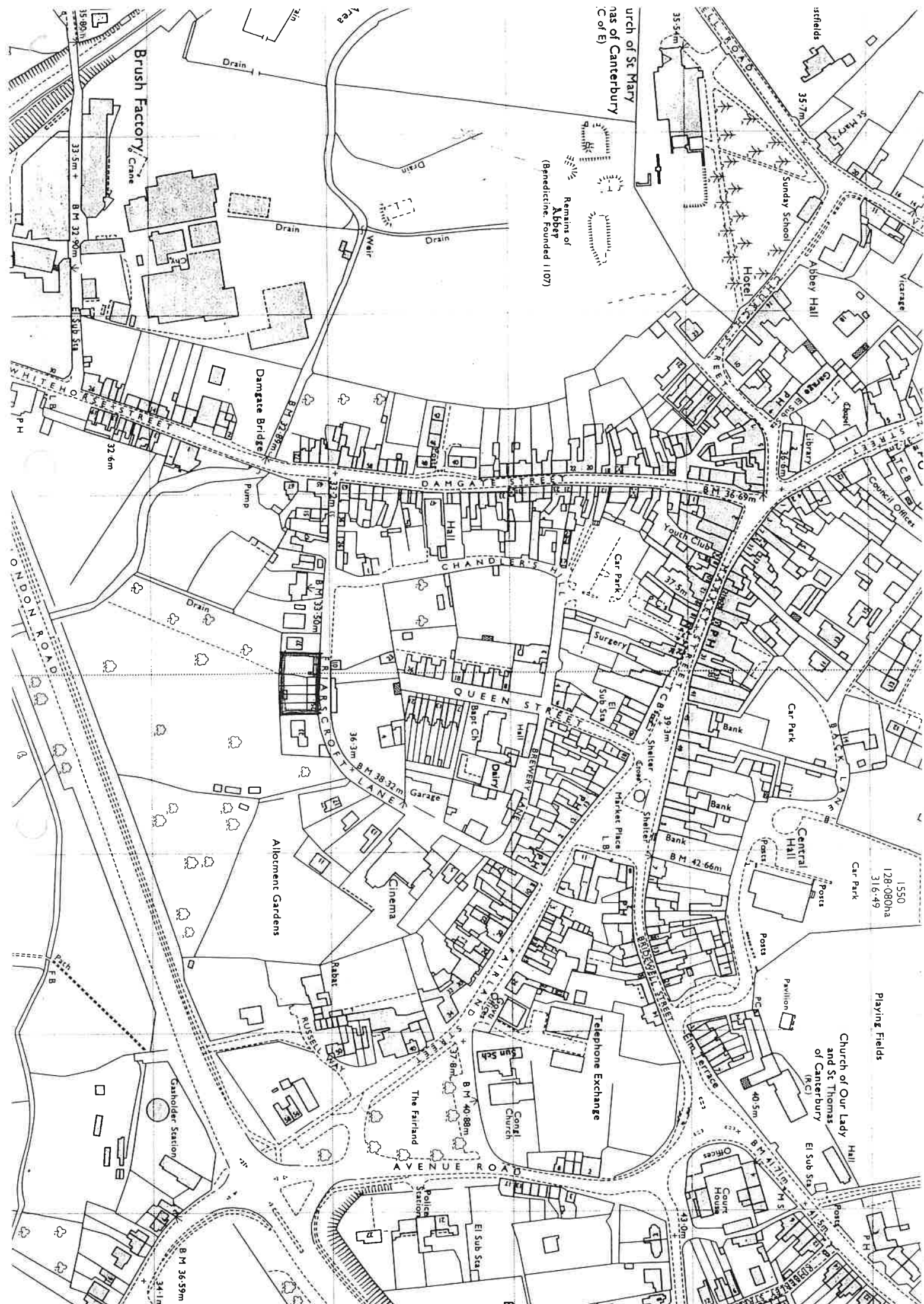
Alterations to any of the windows on the street frontages of the dwellings (being development falling within Schedule 2 Part I Class A of the Order).
