lof the said property so that the aforementioned extension proposed to be constructed on the land shown coloured red on the plan marked "A" remains after the expiry of that period of six months as a separate complete free-standing dwellinghouse.

Subject to the grant of planning permission mentioned above and pursuant to the said Section 52 the owners hereby jointly and severally covenant with the Council that the said existing building known as Rosedene aforesaid shall not at any time hereafter be occupied by any person other than the said Ronald Samuel Jeffries.
