W H E R E A S:

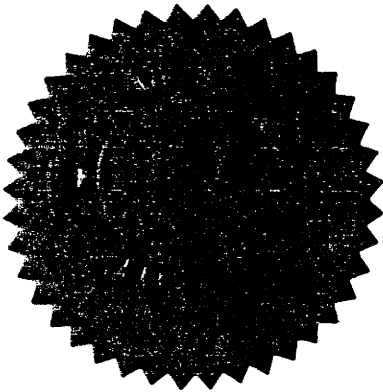
- (1) This Deed is supplemental to an Agreement ("the Agreement") dated 11th January 1978 and made between the Broadland District Council and the Second Owners
- (2) The Broads Authority are the successor planning authority to the Broadland District Council by virtue of the provision of the Norfolk and Suffolk Broads Act 1988
- (3) The First Owners have acquired the freehold interest in the land shown edged blue on the plan attached to this Deed
- (4) The First Owners wish to undertake a different business arrangement to that envisaged at the date of the Agreement
- (5) In the light of the fresh proposals referred to in Recital (4) above the parties hereto have agreed to vary the provisions of the Agreement in the manner hereinafter appearing

N O W T H I S D E E D W I T N E S S E T H as follows:-

1. From the date hereof the Agreement shall at all times be read construed and take effect as though:-
 - (a) the land shown edged blue on the attached plan were subject to the conditions referred to in paragraph 2 of the Second Schedule of the Agreement instead of paragraph 1
 - (b) paragraph 2 (C) of the Second Schedule referred to the management mooring and operation on the blue land of 17 private and/or hire fleet boats with a maximum of 100 berths rather than the management mooring and operation of a boat hire fleet
2. Except as varied as aforesaid the Agreement and every clause thereof shall continue to be of full effect and to be binding on the respective parties thereto
