## WHEREAS

- 1. The Council is a Local Planning Authority for the purposes of this
  Agreement
- 2. The owners are seized in fee simple absolute in possession of the property (hereinafter called "the Property") known as 18 Stone Hill Rackheath aforesaid which is more particularly described in a Conveyance dated the eighteenth day of July One thousand nine hundred and eighty-four and made between Town William Horton of the one part and the Owners of the other part subject to the mortgage next hereinafter recited but otherwise free from incumbrances
- 3. By a mortgage dated the twenty-third day of September One thousand nine hundred and eighty-seven and made between the Owners of the one part and the Mortgagee of the other part the Property was charged in favour of the Mortgagee to secure the repayment of the monies mentioned therein
- 4. The Owners have applied to the Council under reference number 88.3186 for planning permission to construct a building on the Property
- 5. The Council the Owners and the Mortgagee have agreed subject to planning permission being granted in consequence of that application to enter into this Agreement pursuant to Section 52 of the Town and Country Planning Act 1971

## NOW THIS DEED WITNESSETH as follows:

- 1. Subject to planning permission being granted in consequence of application number 88.3186 and pursuant to the said Section 52—the Owners hereby jointly and severally agree declare and covenant with the Council that from the date on which the aforesaid planning permission shall be granted the Property shall be permanently subject the conditions restricting or regulating the development or use of the Property specified in the Schedulereto
- 2. Likewise subject to that planning permission being granted and pursuant the said Section 52 the Mortgagee hereby agrees declares and covenants with the Council that at any time when it is in possession of the Propert it shall observe and perform the said conditions specified in the Schedul hereto and furthermore that if it shall exercise its power of sale as a Mortgagee it shall ensure that in the Conveyance or Transfer of the Property the Purchaser from it shall covenant to bind himself and his successors in title at all times up observe and perform the said condition specified in the Schedule hereto
- 3. The expressions "the Council" "the Owners" and "the Mortgagee" shall where the context so admits include their respective successors in title and assigns
